EXTRACT OF A PORTION OF THE MINUTES OF THE VILLAGE BOARD OF TRUSTEES OF THE VILLAGE BOARD OF PALMYRA, OTOE COUNTY, NEBRASKA, HELD ON FEBRUARY 13, 1973, IN CONNECTION WITH PROCEEDINGS ADOPTING ORDINANCE NO. 88 OF SAID VILLAGE.

The Chairman announced the introduction of Ordinances was now in order whereupon Ordinance No. 88 was introduced by Trustee C. A. Lachley and is in words and figures as follows, to-wit:

ORDINANCE NO. 88

AN ORDINANCE TO ANNEX TO THE VILLAGE OF PALMYRA, A TRACT OF LAND DESCRIBED AS MAHONEY'S REPLAT, AN ADDITION TO THE VILLAGE OF PALMYRA, OTOE COUNTY, NEBRASKA, TO APPROVE A REPLAT OF BLOCK A, WAIT'S ADDITION TO THE VILLAGE OF PALMYRA, AND TO DECLARE AN EMERGENCY.

BE IT ORDAINED BY THE CHAIRMAN AND BOARD OF TRUSTEES OF THE VILLAGE OF PALMYRA, OTOE COUNTY, NEBRASKA.

Section 1. That there be, and there hereby is annexed to the corporate limits of the Village of Palmyra, Otoe County, Nebraska, the following described contiguous property owned solely by Carroll Thompson and Susan Thompson, husband and wife, to-wit:

A tract of land in the East Half (E 1/2) of the Northeast Quarter (NE 1/4) of the Northeast Quarter (NE 1/4) of Section Thirty-four (34), Township Nine (9) North, Range Nine (9) East of the 6th P. M., Otoe County, Nebraska, described as follows:

The South Half (S 1/2) of the Northeast Quarter (NE 1/4) of the Northeast Quarter (NE 1/4) of the Northeast Quarter (NE 1/4) of Section Thirty-four (34), Township Nine (9) North, Range Nine (9), East of the 6th P. M., Otoe County, Nebraska.

Section 2. That said tract as shown on the attached duly certified Plat made a part hereof by reference shall be named and hereafter carry the title of "MAHONEY'S REPLAT, AN ADDITION TO THE VILLAGE OF PALMYRA, OTOE COUNTY, NEBRASKA."

Section 3. That said Plat of MAHONEY'S REPLAT, AN ADDITION TO THE VILLAGE OF PALMYRA, OTOE COUNTY, NEBRASKA a tached hereto and made a part hereof by reference is hereby approved.

Section 4. The replat of Block A, Wait's Addition to the Village of Palmyra, Otoe County, Nebraska, as reflected on the attached plat made a part hereof by reference is hereby approved.

Section 5. That this Ordinance shall become effective upon the filing in the office of the Register of Deeds of Otoe County, Nebraska, a certified copy of this Ordinance together with a certified copy of the Plat attached hereto. That upon such filing the inhabitants of said territory shall enjoy all of the privileges and benefits of said Village and be subject to the Ordinance and Regulations of said Village.

Section 6. An emergency is hereby declared and this Ordinance shall go into effect upon the publishing hereof as provided by law and in this Ordinance.

Passed and approved this 13th day of February, 1973, by a vote of 4 for and 0 against.
