AFFIDAVIT OF CORRECTION

94th Street and lots 4 and 5, Block 43, Maple Village, a subdivision in Douglas County, Nebraska, as surveyed, platted and recorded, is corrected as shown:

The street dimension of 94th Street along the Southerly Right-of-Way line of Sprague Street to read "fifty-one and seventy-four hundredths feet (51.74') "instead of "fifty-one and sixteen hundredths feet (51.16') "."

The Northerly curved line of Lot 4 to read "fifty-one and eighty-five hundredths feet (51.85') " instead of "fifty-two and forty-three hundredths feet (52.43') ".

The South line of Lot 4 to read "eighty-three and twenty-five hundredths feet (83.25') " instead of "eighty-four and twenty-two hundredths feet (84.22') ".

The Northerly line of Lot 5 to read "one hundred sixty-two and thirty hundredths feet (162.30') " instead of "one hundred sixty-three and twenty-seven hundredths feet (163.27') ".

The angle in the Northeasterly corner of Lot 5 to read "ninety-one degrees, forty minutes, forty seconds (91° 40' 40'') " instead of "ninety degrees, forty minutes (90° 40') ".
