No structures shall be erected, altered placed, or permitted to remain on any residential building plot other than one detached single-family dwelling not to exceed two stories in height and a private garage for not more than two cars.
 - No building shall be erected nearer to the front lot line nor nearer to the side street line than permitted by the City of Omaha, Douglas County, Nebraska. In any event, no building shall be located on any residential building plot nearer than thirty-five (35) feet to the front lot line nor nearer to any side street line as provided by the City of Omaha, Douglas County, Nebraska. No building except a detached garage or other outbuildings located thirty-five (35) feet or more from the front lot line shall be located nearer than five (5) feet to any side lot line. No residence or attached appurtenance shall be erected on any lot further than 40 feet from the front lot line.
 - c) No residential structure shall be erected or placed on any building plot, which plot has an area of less than 5,000 square feet or a width of less than 50 feet at the front building setback line.
 - D) No norious or offensive trade or activity shall be carried on upon any lot nor shall anything be done thereon which may be or become an annoyance or nuisance to the meighborhood.
 - E) No trailer, basement, tent, shack, garage, barn or other outbuilding erected in the tract shall at any time be used as a residence temporarily or permanently nor shall any structure of a temporary character be used as a residence.
 - F) The ground area of the main structure, exclusive of onestory open porches and garages, shall be not less than 720 square feet in the case of a one-story structure and 650 square feet in the case of a 12 or 2 story, structure.
 - G). An easement is reserved over the rear 5 feet of each lot, and over 2 feet adjoining each side lot line, for utility installations and maintenance.
