Whereas the land covered by the above described mortgage, is a part of the above described Lots being subdivided.

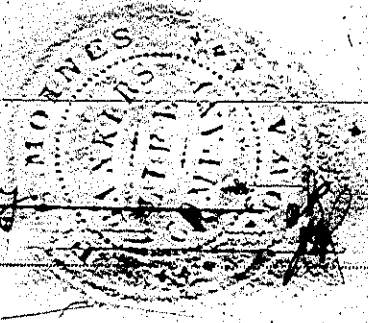
