ORDINANCE No. 99-2

AN ORDINANCE ADOPTING CODE OF ORDINANCES FOR MILLS COUNTY, IOWA

Be it an act by the Board of Supervisors Of Mills County, Iowa:

Section 1. PURPOSE. The purpose of this adopting of ordinances is to enable Mills County, Iowa, to comply with the provisions of Section 331.302 of the Code of Iowa.

Section 2. ADOPTION. Mills County, Iowa, hereby adopts the 1999 Code of Ordinances for Mills County, Iowa, pursuant to the provisions for notice of hearing of Section 331.302 of the Code of Iowa.

Section 3. CONTENT. The 1999 Code of Ordinances of Mills County, Iowa, is composed of all County Ordinances presently in effect, except grade ordinances, bond ordinances, and/or ordinances vacating streets and alleys.

The 1999 Code of Ordinances shall include this adoption ordinance and the County Auditor certification of its adoption and passage.

Section 4. FORMAT. The 1999 Code of Ordinances of Mills County, Iowa, shall be compiled in a loose leaf format.

Section 5. OFFICIAL COPY. The County Auditor shall be responsible for the compilation, organization and maintenance of the official 1999 Code of Ordinances of Mills County, Iowa, and shall keep the official copy on file in the office of the Mills County Auditor.

Section 6. PUBLIC COPIES. Additional copies of the 1999 Code of Ordinances shall be kept in the office of the County Auditor and shall be available for public inspection and purchase.

Section 7. ADDITIONAL ORDINANCES. All ordinances except as hereinafter provided, adopted after the effective date of the ordinances shall be in the form of an amendment to or an addition to the 1999 Code of Ordinances. This section does not apply to grade ordinances, bond ordinances and/or ordinances vacating streets and alleys.

Section 8. **EFFECTIVE DATE.** This ordinance, after its passage and publication, as required by law, shall be effective as of the 1st day of November, 1999.

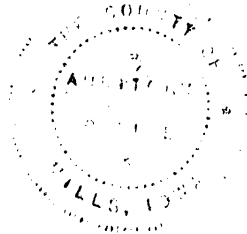
