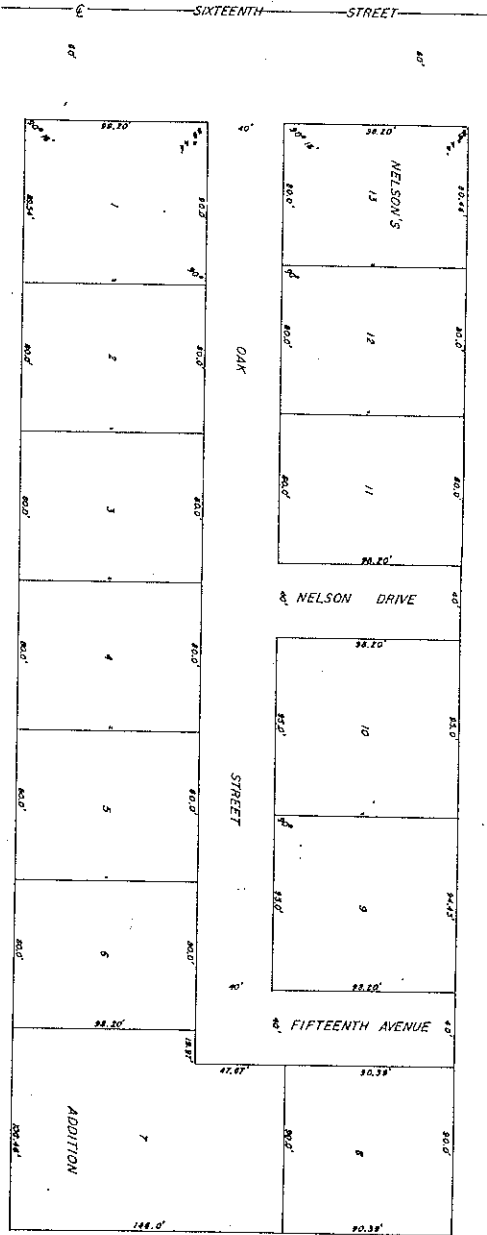


VACATION PLAT

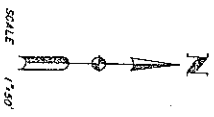

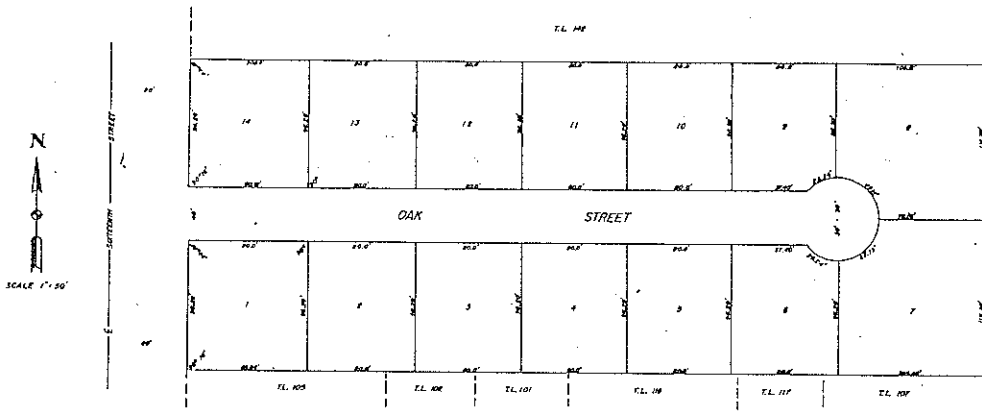
