## WATER WELL AGREEMENT

THIS AGREEMENT made this \_\_\_\_\_ day of August, 2006, by and between Harry S. Crouse and Kristina. Crouse, Husband and Wife ("Crouses"), Kurt L. Loseke and Kari A. Loseke, Husband and Wife ("Losekes"), and Roger D. Mathiesen and Judy K. Mathiesen, co-Trustees of the Roger D. Mathiesen Living Trust dated April 12, 2002, and Judy K. Mathiesen and Roger D. Mathiesen, co-Trustees of the Judy K. Mathiesen Living Trust dated April 12, 2002 ("Mathiesens").

WHEREAS, Crouses are the owners of Lot 2, North Creek Subdivision, lying in the Northwest Quarter (NW 1/4) in Section 4, Township 18 North, Range 11, East of the 6<sup>th</sup> P.M., Washington County, Nebraska, and own the well located on such property ("Crouse Property").

WHEREAS, Losekes are the owners of Lot 1, North Creek Subdivision, lying in the Northwest Quarter (NW 1/4) in Section 4, Township 18 North, Range 11, East of the 6th P.M., Washington County, Nebraska, which is serviced by the well located on the Crouse Property ("Loseke Property").

WHEREAS, the Mathiesens desire to have access to the well on the Crouse Property for agriculture or other purposes as agreed by the parties.

WHEREAS, the parties hereto agree to enter into this Agreement whereby the Mathiesens and the Losekes shall be entitled to use the water well located on the Crouse Property and agree to define the duties and obligations of the parties in regard to such water well.

NOW, THEREFORE, IN CONSIDERATION OF THE MUTUAL COVENANTS AND PROMISES HEREIN, THE PARTIES AGREE AS FOLLOWS:

- I. Water Well: Losekes may use the water well located on the Crouse Property which shall primarily be used for domestic consumption of water for the Loseke Property, and may be utilized, on a secondary basis, for the watering of livestock. The parties further agree that Mathiesens shall have an unrestricted use of water from the water well for their purposes, whether for agricultural or otherwise.
- 2. Repair. Maintenance and Operation of Water Well: The parties hereto agree that Crouses and Losekes shall pay and be responsible for all repairs, replacements or maintenance of the water well and shall also pay and be responsible for any electricity necessary to operate said water well. Any repairs which cost in excess of One Hundred Dollars (\$100.00) shall be upon mutual agreement of Crouses and Losekes and each party agrees to pay their one-half (1/2) share within a reasonable period of time after the invoice is delivered.
- 3. Exclusive Use: The parties hereto agree that the water well shall be for the exclusive use of Crouses, Losekes and Mathiesens, and the right to use said well shall not be assigned to any third parties without the prior written consent of all parties hereto.
- Prior Agreement Superceded: The Water Well Agreement between the parties dated April
   2002, and recorded in the office of the County Clerk of Washington County, Nebraska at Book
   Pages 56-61 is hereby superceded.
