AMENDMENT TO DECLARATION OF PROTECTIVE COVENANTS

THIS AMENDMENT TO DECLARATION OF PROTECTIVE COVENANTS (the "Amendment") is made as of the 9th day of March, 1992, by 144TH AND CENTER PARTNERSHIP, a Colorado general partnership, (the "Colorado Partnership"), CONSTRUCTION DEVELOPERS, INCORPORATED, an Arkansas corporation, CENTER ROAD RETAIL DEVELOPERS LIMITED PARTNERSHIP, an Indiana limited partnership, KV-CENTER ASSOCIATES, a Nebraska general partnership, WESTERN AUTO SUPPLY COMPANY, a Delaware corporation, FIRSTIER, N.A., a national banking association, SNOWSTATE RESTAURANT CORPORATION, a Texas corporation, and J.S. VENTURES, INC., a Kansas corporation.

WITNESSETH:

WHEREAS, Parcel 520 Associates, a Nebraska general partnership, KV International, Inc., a Nebraska corporation, 140th and Center Partnership, a Colorado general partnership, the County of Douglas, Nebraska, and May and Oxner Partnership, a Nebraska general partnership, executed that certain Declaration of Protective Covenants, dated as of February 12, 1986, and recorded May 20, 1987 in the Office of the Register of Deeds of Douglas County in Miscellaneous Book 815, Page 326 (the "Declaration"); and

WHEREAS, the parties hereto constitute (a) all of the Owners (as described in the Declaration) of all of the Building Sites (as defined in the Declaration) upon which the regional enclosed mall shopping center (as defined herein) is located, and (b) seventy-five percent (75%) of the Owners of all of the Building Sites within and constituting at least seventy-five percent (75%) of both (i) the Property (as defined in the Declaration) as a whole, and (ii) the Property not including the Building Sites upon which the regional enclosed mall shopping center is located; and

WHEREAS, (a) the majority of the Property was replatted as Lots 1-21, inclusive, in Oak View, a Subdivision, as surveyed, platted and recorded in Douglas County, Nebraska, and (b) said Lots 1-21 constitute all of the Property, save and except for (1) the portion of Lot 4 of Omaha Industrial Foundation ("O.I.F.") District No. 4, Replat One, which is owned by the Colorado Partnership, and (2) the portion of Lot 3 of the O.I.F. District No. 4, which is owned by Safety Kleen Corp., a Wisconsin corporation; and

WHEREAS, the parties hereto desire to confirm that (a) Lots 1-15, inclusive, in Oak View, a Subdivision (which Lots 1-15 are collectively referred to in this Amendment as the "Shopping Center Property"), shall constitute the "Regional Enclosed Mall Shopping Center", (b) the term "Regional Enclosed Mall Shopping Center" shall be defined to mean the Shopping Center Property, for all purposes of, and as such term "Regional Enclosed Mall Shopping

Center" is used in, the Declaration, and (c) the Shopping Center Property shall not be subject to any covenants, conditions, regulations, restrictions, reservations or burdens contained in the Declaration.

NOW, THEREFORE, in consideration of the mutual covenants herein contained, and pursuant to Paragraph 9.2 of the Declaration, the parties hereto agree as follows:

1. (a) The Shopping Center Property does and shall constitute the "Regional Enclosed Mall Shopping Center" for all purposes of, and as such term "Regional Enclosed Mall Shopping Center" is used in, the Declaration, (b) the term "Regional Enclosed Mall Shopping Center" shall be defined to mean the Shopping Center Property, for all purposes of, and as such term "Regional Enclosed Mall Shopping Center" is used in, the Declaration, and (c) the Shopping Center Property shall not be subject to any covenants, conditions, regulations, restrictions, reservations or burdens contained in the Declaration; provided, however, the terms and provisions of the Declaration shall continue to inure to the benefit of the Shopping Center Property. Both "Regional Enclosed Mall Shopping Center" and "regional enclosed mall shopping center" are used in the Declaration, and for all purposes of the Declaration and this Amendment, such two terms shall be deemed to be identical.

2. Except as amended herein, the Declaration remains in full force and effect.

3. This Amendment to Declaration of Protective Covenants is executed in several counterparts, each of which shall be deemed an original, and all such counterparts shall together constitute one and the same instrument.

IN WITNESS WHEREOF, the parties have caused this Amendment to Declaration of Protective Covenants to be executed as of the day, month and year first above written.



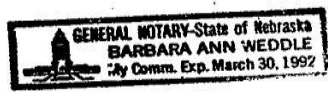

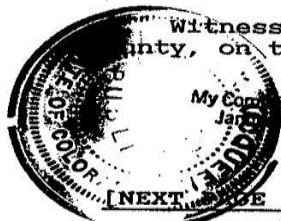
