ASSIGNMENT OF AGREEMENTS BOOK 1019 PAGE 472 (RECORDED AGREEMENTS)

THIS ASSIGNMENT OF AGREEMENTS ("Assignment"), is made as of the /s+ day of July , 1992 by and between CENTER ROAD RETAIL DEVELOPERS LIMITED PARTNERSHIP, an Indiana limited partnership ("Center Road") and OAK VIEW MALL CORPORATION, a Delaware corporation ("Oak View").

RECITALS

RECITAL 1: Pursuant to that certain Agreement of Sale ("Agreement of Sale") dated as of the 28th day of April, 1992, by and among Center Road and Oak View, Center Road agreed to assign to Oak View all of Center Road's right, title, estate and interest in, to and under all of the agreements (the "Agreements") benefiting the real estate legally described in Exhibit "A" attached hereto commonly known as the Oak View Mall. Concurrently herewith, Center Road is delivering to Oak View a general assignment of all of Center Road's interest in, to and under certain rights and interests in the Oak View Mall, including the Agreements (the "General Assignment").

RECITAL 2: Pursuant to the terms of this Assignment, Center Road wishes to reaffirm the General Assignment with respect to those Agreements previously filed of record (the "Recorded Agreements").

NOW, THEREFORE, in consideration of the foregoing recitals, both of which are made a part hereof, and for other good and valuable consideration, the receipt and sufficiency of which Center Road hereby acknowledges, Center Road and Oak View hereby agree as follows:

- Center Road does hereby assign and transfer to Oak View and Oak View does hereby accept all of Center Road's right, title, estate and interest in and to the Recorded Agreements described in Exhibit "B" attached hereto, including, without limitation, all of Center Road's review, approval, consent, designation and/or voting rights as the developer or owner of all or any part of the Oak View Mall set forth in the provisions of the Recorded Agreements.
- Center Road agrees that it will execute and deliver to Oak View (or its designees) such additional documents reasonably requested by Oak View in order to further evidence, confirm, or

effect the transfer of the Assigned Rights sought to be effected hereby, all at no further cost or expense to Oak View.

- 3. This Assignment and the provisions hereof shall be binding upon and inure to the benefit of the parties hereto and their respective successors, assigns and legal representatives.
- 4. All of the other terms and conditions of the General Assignment are hereby incorporated herein by this reference thereto as if fully set forth herein in their entirety, including, without limitation, Paragraph 8 thereof.
