WHEREAS, the parties hereto desire to more clearly define their rights under such Easement Grant and further desire to mod- ify and amend said Easement Grant in certain respects.

1. That Northern shall, and by these presents does, hereby limit its right-of-way under the aforedescribed Easement Grant, to a strip of land 100 feet in width over the 16-inch pipeline and 45 feet in width over a 2-inch pipeline over and across the property of the Owner as last described above, the centerline of the 100 foot strip shall be the present location of Northern's 16-inch pipeline, and the North line of the 45 foot strip shall be 25 feet North of Northern's 2-inch pipeline.
