MODIFICATION AND AMENDMENT OF EASEMENT GRANT

This instrument made and entered into this 13 th day of

THERN") and OVERLAND HILLS, a Partnership, (hereinafter referred

WITNESSETH THAT:
WHEREAS, Northern is the holder of an Easement Grant covering
the following described premises in Sarpy County, Nebraska:
The Southwest Quarter (SW ₂) of Section Twenty-seven (27), and the North Three Quarters of the West Half of the Northwest Quarter (N3/4 W1/2 NW1/4) of Section Thirty-four (34), all in Township Fourteen (14) North, Range Twelve (12), East of the 6th P.M., in Sarpy County, Nebraska,
which Easement Grant has been recorded in Book 15 of Misc.
at Page 40 , in the Office of the Register of.
Deeds for Sarpy County, Nebraska; and
WHEREAS, pursuant to the authority contained in said Easement Grant, Northern has constructed and currently operates and maintins a 16-inch and 2-inch pipeline through and across the premises above described; and
WHEREAS, of the premises described in said Easement Grant, Owner is the premise of the following described premises:
All the property described above.
WHEREAS, the parties hereto desire to more clearly define their rights under such Easement Grant and further desire to mod- ify and amend said Easement Grant in certain respects.
NOW, THEREFORE, in consideration of the premises and of the mutual covenants and agreements hereinafter set forth, it is agreed by and between the parties hereto as follows:
1. That Northern shall, and by these presents does, hereby limit its right-of-way under the aforedescribed Easement Grant, to a strip of land 100 feet in width over the 16-inch pipeline and 45 feet in width over a 2-inch pipeline over and across the property of the Owner as last described above, the centerline of the 100 foot strip shall be the present location of Northern's 16-inch pipeline, and the North line of the 45 foot strip shall be 25 feet North of Northern's 2-inch pipeline. A plat is attached hereto as Exhibit "A".
2. That Northern shall, and by these presents does, hereby release from its said Easement Grant all of the above described property of the Owner except the strip of land described in Paragraph 1 above, upon which strip said Easement Grant is retained as borein modified.
