ORDINANCE NO. 3750

AN ORDINANCE CREATING SANITARY SEWER DISTRICT NO. 95-1 OF THE CITY OF FREMONT, NEBRASKA; ESTABLISHING THE OUTER BOUNDARIES OF THE DISTRICT; DESIGNATING THE SIZE, LOCATION AND TERMINAL POINTS AND REFERRING TO THE PLANS AND SPECIFICATIONS AND ESTIMATE OF THE ENGINEER IN CONNECTION THEREWITH ON FILE WITH THE CITY CLERK; AND PROVIDING FOR AN EFFECTIVE DATE.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF FREMONT, NEBRASKA:

SECTION I. The Mayor and City Council of the City of Fremont, Nebraska, hereby find and determine that it is necessary and advisable to extend the municipal sanitary sewer service to beyond the existing system by the construction of sanitary sewers, and for the purpose of constructing said sewers, there is hereby created Sanitary Sewer District No. 95-1 of the City, and within said district, there shall be constructed an 8-inch sanitary sewer together with all necessary appurtenances in Ohio Street from Seaton Avenue to the west margin of Washington Heights 2nd Addition. The outer boundaries of Sanitary Sewer District No. 95-1 shall include all lots and lands north of Ohio Street from Seaton Avenue to the west margin of Washington Heights 2nd Addition, Dodge County, Nebraska, to a depth of 105 feet and all lots and land lying south of Ohio Street in R and R Johnson's Subdivision, Dodge County, Nebraska, to a depth of 105 feet.

SECTION II. Reference is hereby made to the plans and specifications for the sewer extension which have been prepared by the City Engineer, by order of the Mayor and City Council and which, together with the Engineer's estimate of the total cost of the proposed extension, have heretofore been filed with the City Clerk and are hereby approved.

SECTION III. The Engineer's estimate of the total cost of the project for Sanitary Sewer District No. 95-1 is \$18,538.00.

SECTION IV. EFFECTIVE DATE. This ordinance shall be in full force and effect from and after its passage, approval and publication according to law.
