Whom it may Concern.. An Ordinance fixing and establishing exclusions and restrictions on private property and lands abutting upon both sides of 31st Avenue between page and Davenport Streets, and abutting upon the west side of 31st Avenue from the North Fine of Lots 11 and 12, Block 3, Summit Place Addition, to Dodge Street, in the City of Omaha, and abating and foreclosing the owners' right to use such property within such restrictions and exclusions.

WHEREAS, a proper petition has heretofore been filed as required by law, asking for the establishing and fixing of certain restrictions and exclusions upon the property mentioned in the title of this ordinance; and,

WHEREAS, all the proceedings required to be taken under the terms of Chapter 213 of the Laws of the Thirty-Fourth Session of the Nebraska Legislature have been complied with, and the City Council of the City of Omaha has found and hereby finds such to be the fact:

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF OMAHA:

Section 1. That there is hereby fixed and established restrictions upon the tracts and parcels of land abutting upon both sides of 31st Avenue between Dodge and Davenport Streets. and abutting upon the west side of 31st Avenue from the north line of Lots 11 and 12, Blook 3, Summit Place Addition, to Dodge Street, in the City of Omaha, as follows:

Prohibiting and excluding the erection and maintenance of any factory, store, or business house, theater, or moving picture house, upon and from the lets, tracts and paracis of land hereinafter described. The Lots, tracts and parcels of land to be affected by the

proposed restrictions and exclusions, as above provided, are as follows:

Lots 1 to 10 inclusive, Block 3, Summit Place,

Lot 1, Block 6, West End Addition.

Lots 1 to 9 inclusive, Block 5, West End Add.

Lots 14 to 22, inclusive, Block 4, West End Add:

Lots 5 and 7, Block 6, Hillside Addition No. 1

All of said lots, tracts and parcels of land being situated in the City of Omaha, Douglas County, Nebraska.

And the owners' right to use said property within said restrictions is hereby abated and foreclosed.

Section 2. That the City Clerk is hereby directed to file a copy of this ordinance with the Register of Deeds of Douglas County, Nebraska, and cause a copy of said ordinance to be filed with the building department of the City, and the building department is hereby directed to file the same and keep a public record thereof in the office of said department.

Section 3. That this ordinance shall take effect and be in force from and after fifteen days after its passage.
