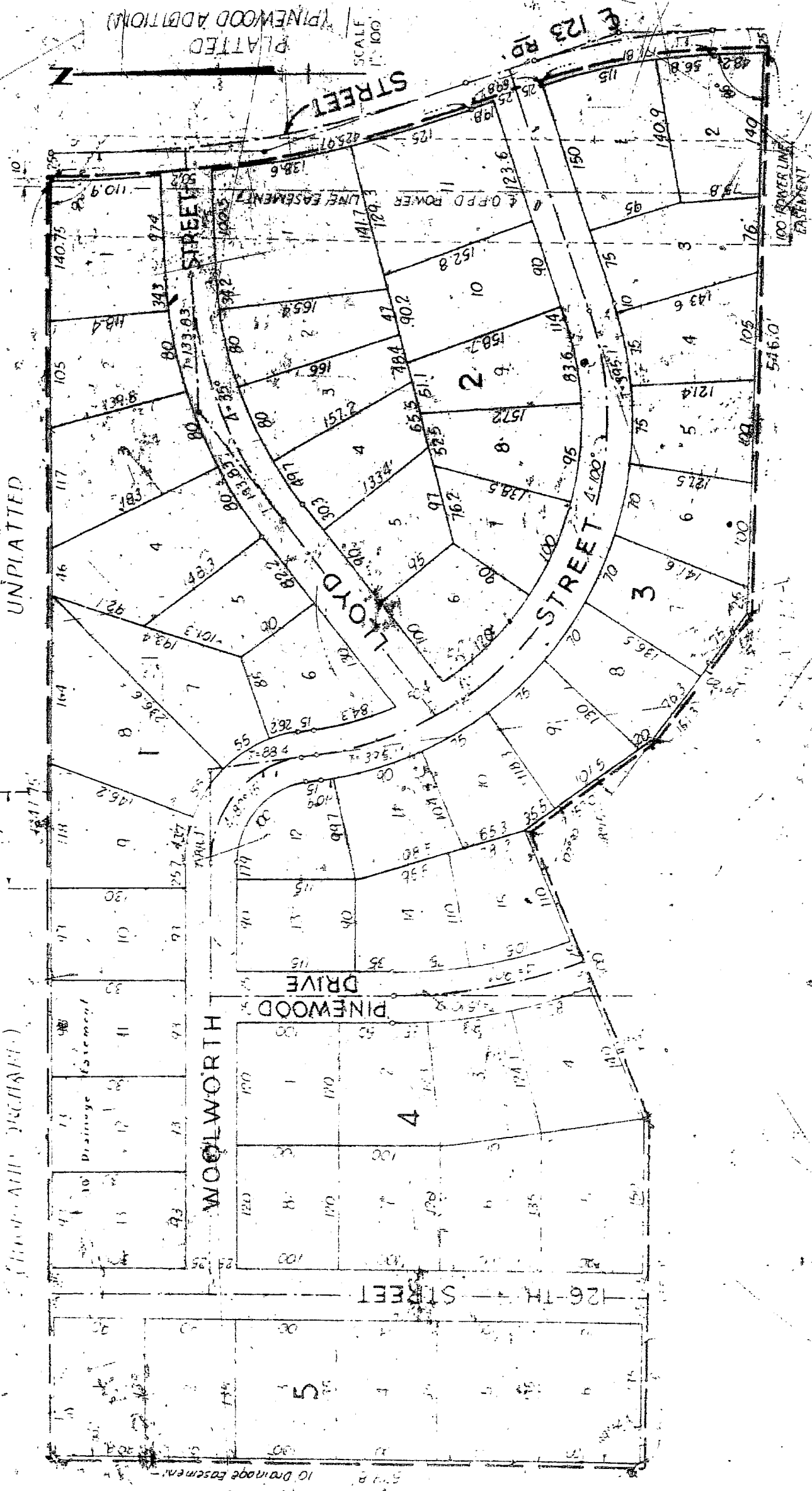

That I have accurately surveyed and staked with iron pipe the lots and streets in Pinewood Second Addition as shown on this plat, also an iron pipe at all points marked thus * on the plat.

That Pinewood Second Addition is located in the S $\frac{1}{2}$ of the NE $\frac{1}{4}$ of Section 30, T. 15 N., R. 12 E. of the 6 th P.M., Douglas County, Nebraska and more particularly described as follows: Starting at the northeast corner of the S $\frac{1}{2}$ of the NE $\frac{1}{4}$ of said Section 30 thence S 89° 40' 10" W a distance of 1392.0 feet to point of beginning of parcel of land herein described, said point being the northwest corner of Pinewood Addition, thence continuing S 89° 40' 10" W a distance of 1247.75 feet; thence S 0° 02' 30" E. a distance of 579.8 feet; thence N 89° 52' 10" E. a distance of 335.0 feet; thence N 66° 45' 10" E a distance of 300.0 feet; thence S 35° 44' 50" E a distance of 157.0 feet; thence S 53° 59' 50" E. a distance of 151.3 feet; thence S 88° 19' 50" E. a distance of 546.0 feet; thence N 2° 19' 50" W a distance of 48.2 feet to the point of beginning of a curve bearing northerly and having a central angle of 16° and a radius of 625.34 feet; thence along said curve a distance of 171.81 feet to the end of said curve, thence continuing N 18° 19' 50" W a distance of 69.8 feet to the point of beginning of a curve having a central angle of 18° and a radius of 1355.9 feet; thence along said curve a distance of 425.97 feet to end of said curve, said end being the point of beginning and the northeast corner of parcel of land herein described.

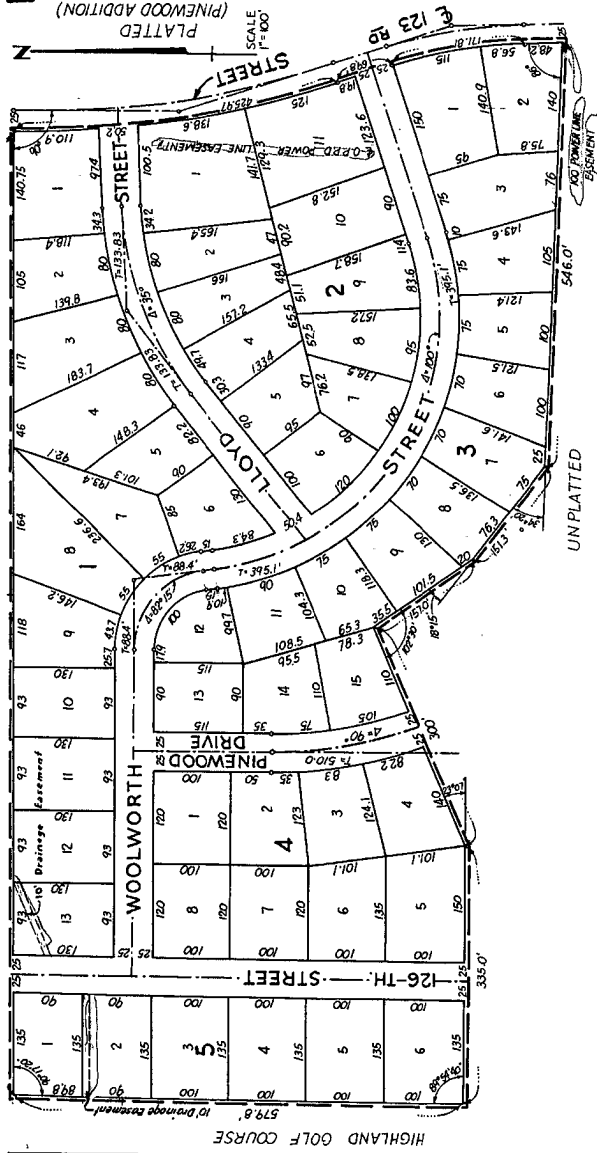
