

ORDINANCE NO. 23351

AN ORDINANCE extending the limits of the City of Omaha over certain land in Douglas County, Nebraska, and incorporating the same into and making the same a part of the City of Omaha and to provide the effective date hereof.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF OMAHA:

Section 1. That the corporate limits of the City of Omaha be extended over and that there be included therein the following described land in Douglas County, Nebraska, which presently adjoins the City Limits of the City of Omaha, as it now exists:

Beginning at a point on the existing City limits as established by Ordinance No. 22193, said point being on point of intersection of the Easterly Right-of-way line of interstate highway No. 280 and the South line of the Northeast one-quarter (NE 1/4) of section 32, Township 15 North, Range 12, East of the 6th Principal Meridian, Douglas County, Nebraska; thence West along the South line of said Northeast one-quarter (NE 1/4) to the East line of Lot 1, Block 8, Prairie Hills, an addition as surveyed, platted and recorded in Douglas County, Nebraska; thence Southerly along the East line of said Lot 1 to the Southeast corner of said lot; thence Northwesterly along the South line of said Lot 1 to the Southwest corner of said Lot 1; thence Westerly to the Northeast corner of Lot 13, Block 10, said Prairie Hills Addition; thence West to the Northwest corner of Lot 11, Block 16, Prairie Lane Addition, an addition as surveyed, platted and recorded in Douglas County, Nebraska; thence Southerly and Southwesterly along the Western line of said Block 16 and said Western line extended to the Northern most corner of Block 30 of said Prairie Lane Addition; thence Northwesterly and Westerly along the South property line of Prairie View Drive to the Northeast corner of Lot 9, Block 26, said Prairie Lane Addition; thence Northerly along the West property line of 117th St. extended to the Northeast corner of Lot 8, Block 22, of said Prairie Lane Addition; thence Westerly along the South property line of Valley Street to the Northwest corner of Lot 9, Block 24, said Prairie Lane Addition; thence North along a line 33' East of and parallel to the West line of Section 32, Township 15 North, Range 12, East of the 6th Principal Meridian, Douglas County, Nebraska to a point 1321.7' South of the North line of said Section 32, thence North 89° 30' 40", East 635.44'; thence Southerly 50.22' to the Northwest corner of Lot 6, Block 7, said Prairie Lane Addition; thence North 89° 30' 40" East 799.72'; thence Northeast-erly along a curve whose radius is 50' to the Southwest corner of Lot 182 Westwood Terrace, an Addition as surveyed, platted and recorded in Douglas County, Nebraska; thence North 89° 30' 40" East 1195.75'; thence Northerly along the East line of 114th Street, 755 feet thence East along North line of Elm Street 411.09 feet; thence South to the Northeast corner of lot 8, Block 4, said Prairie Hills Addition thence Southerly along the East line of Lots 8 through 14, Block 4, to the Southwest corner of Lot 1, Block 4, of said Prairie Hills Addition; thence East along the South line of the Northwest one-quarter (NW 1/4) of the Northeast one-quarter (NE 1/4) of Section 32, Township 15 North, Range 12, East of the 6th Principal Meridian, Douglas County, Nebraska to the Easterly property line of 112th Street; thence Southerly to the Southwest corner of Lot 1, Block 3 of said Prairie Hills Addition; thence Easterly to the Southeast corner of Lot 1, Block 3, of said Prairie Hills Addition; thence South to the South line of said Northwest one-quarter (NW 1/4) of the Northeast one-quarter (NE 1/4) of said Section 32; thence East to the Easterly property line of Interstate Highway No. 280; thence Southerly along the Easterly right-of-way line of said Interstate Highway to the point of beginning.

A map of the area is attached hereto, Marked "Exhibit A", and by this reference made a part of this ordinance. The land to be annexed is marked thereon in color, but said map is for convenience and, in case of discrepancy, the description in this section shall be controlling. The said territory upon the taking effect of this ordinance shall be and become incorporated into, merged in, and be a part of the City of Omaha, Nebraska, and subject to the jurisdiction thereof and to its laws and ordinances.

Section 2. That this Ordinance shall be in full force and take effect July 1, 1965.

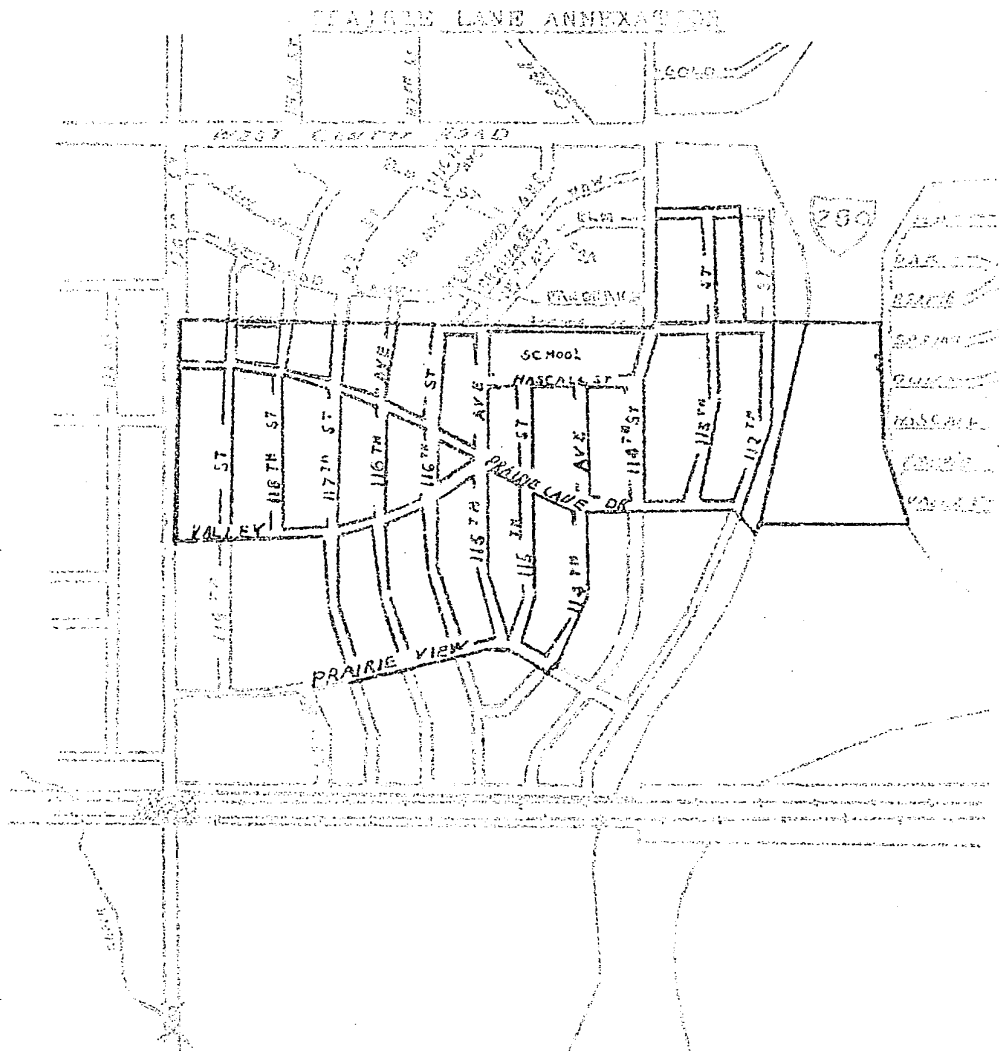
