

ASSIGNMENT OF PERMANENT SANITARY SEWER EASEMENTS

Pursuant to Paragraph 6 of an Agreement For Wastewater Service Between City Of Omaha, Nebraska And City Of Elkhorn, Nebraska of even date herewith, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the City of Omaha, Nebraska, a municipal corporation (Omaha), hereby assigns, transfers, grants, and conveys to the City of Elkhorn, Nebraska, a municipal corporation (Elkhorn), all of Omaha's rights, titles, and interests in and to:

(1) A Permanent Sewer Easement dated May 30, 1989 from Jerold J. Wilke and Nancy B. Wilke, which was recorded on June 13, 1989 in Book 889 at Pages 185 through 195 inclusive of the Miscellaneous Records of the Register of Deeds of Douglas County, Nebraska, and which grants a twenty foot wide permanent sanitary sewer easement in that portion of the Northwest Quarter of Section 25, Township 15 North, Range 10 East of the 6th P.M., Douglas County, Nebraska, which is more particularly described in the legal description which is set forth in Exhibit "A" hereto and incorporated herein by reference.
