

AFFIDAVIT OF CORRECTION

Lot 9, Block 9 and Lot 10, Block 9, RAVEN OAKS, in Douglas County, Nebraska, as surveyed, platted, recorded and corrected as shown:

The angle in the Southeasterly corner of Lot 10, Block 9 to read "fifty four degrees, twelve minutes, forty seconds ($54^{\circ}12'40''$)" instead of "fifty seven degrees, thirty minutes, fifty seconds ($57^{\circ}30'50''$)."

The front lot dimension of Lot 10, Block 9, along Hunt Street, to read "forty nine and twenty four one hundredths ft. ($49.24'$)" instead of "forty six and thirty six one hundredths ft. ($46.36'$)."

The angle formed at the center of the cul-de-sac from the front lot corners of Lot 10, Block 9, to read "fifty six degrees, twenty five minutes, fifty seconds ($56^{\circ}25'50''$)" instead of "fifty three degrees, seven minutes, ten seconds ($53^{\circ}07'10''$)."

The front lot dimension of Lot 9, Block 9, along Hunt Street, to read "forty six and thirty six one hundredths ft. ($46.36'$)" instead of "forty nine and twenty four one hundredths ft. ($49.24'$)."

The angle formed at the center of the cul-de-sac from the front lot corners of Lot 9, Block 9, to read "fifty three degrees, seven minutes, ten seconds ($53^{\circ}07'10''$)" instead of "fifty six degrees, twenty five minutes, fifty seconds ($56^{\circ}25'50''$)."

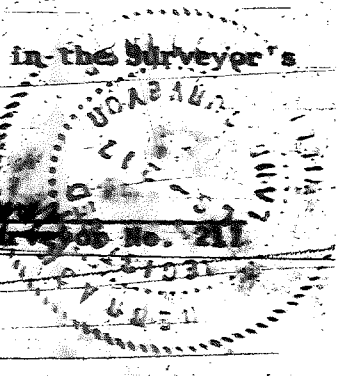
AFFIDAVIT

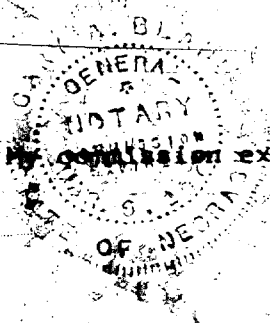
