DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS

This declaration, made on the date hereinafter set forth, by Oakbrook, Inc., a Nebraska Corporation, hereinafter referred to as "Declarant".

AND, HENCEFORTH, unless amended pursuant to the terms of the covenants, conditions and restrictions, the property known as Lots 1, 2, 3, 4, 5, 6, 7,8 and 9, Raven Oaks Replat No. 2, Douglas County, Nebraska, shall be bound by the terms of the Declaration of Covenants, Conditions and Restrictions, dated September 30, 1974, as recorded at Book 542, Page 515, Miscellaneous Records, Register of Deeds, Douglas County, Nebraska, and as amended at the Register of Deeds office, Douglas County, Nebraska, as if originally included therein, said Declaration and Amendments being incorporated herein by reference;

AND, Lots 1 through 14, inclusive, Raven Oaks Replat No. 1, Douglas County, Nebraska, being the subject property of the Declaration of Covenants, Conditions and Restrictions, dated September 30, 1974 and October 24, 1975, shall continue to be bound by said covenants, conditions and restrictions, as amended, since Declarant herein does not alter, revoke, amend or modify
