This ADOPTION and RATIFICATION, made May 28, 1976, by

WITNESSETH: THAT,

Whereas on May 22, 1972, United Benefit executed a Supplementary Declaration as to Regency Townhomes 2nd Addition, a replat of part of Lot 155, Regency 1st Addition, a subdivision in Douglas County, Nebraska, as surveyed, platted, and recorded, as recorded in Book 510, at Page 209, of the Miscellaneous Records of the Register of Deeds of Douglas County, Nebraska, and thereby conferred upon Regency Townhomes Association, a Nebraska nonprofit corporation, hereafter called "Association", the right to modify said Supplementary Declaration; and

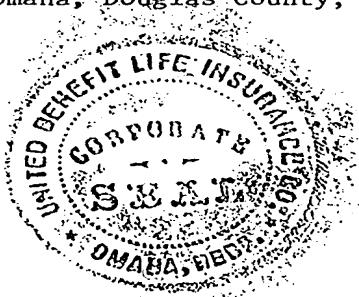

Now, Therefore, for clarification of the record and in consideration of the matters herein recited, United Benefit does hereby

ADOPT and RATIFY

as its own act and deed as from May 22, 1972, said Amendment to Supplementary Declaration as to Regency Townhomes 2nd Addition, a subdivision in Douglas County, Nebraska, as surveyed, platted, and recorded, and particularly as to Lots 155-A4 and 155-G3, G4, G7, and G8 thereof together with the covenants, easements, conditions, and all other terms therein contained.

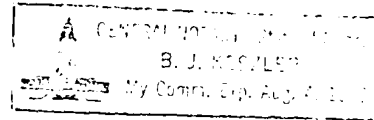
