WITNESSETH: THAT,

Whereas on March 1 1971, United Benefit, then being the owner thereof, conveyed all of Lot 155, Regency 1st Addition, a subdivision in Douglas County, Nebraska, as surveyed, platted, and recorded, to Regency, Inc., a Nebraska business corporation with its registered office in Omaha, Douglas County, Nebraska, wholly owned by United Benefit, by a Warranty Deed by inadvertence not recorded with the Register of Deeds of Douglas County, Nebraska, until August 26, 1971, and as now recorded in Book 1438, at Page 102, of the deed records of the Register of Deeds of Douglas County, Nebraska; and United Benefit consequently appeared to be the owner of record of such property on June 18, 1971, and on July 30, 1971; and

Whereas on June 18, 1971, said Regency, Inc. executed a Replat and Dedication as to part of said Lot 155 as recorded in Book 1435, at Page 367, of the deed records of the Register of Deeds of Douglas County, Nebraska; and on July 30, 1971, said Regency, Inc. executed a Declaration as to Regency Townhomes 1st Addition, a replat of said part of said Lot 155 as recorded in Book 502, at Page 7, of the miscellaneous records of the Register of Deeds of Douglas County,

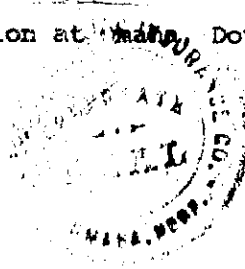

Now, Therefore, for clarification of the record and in consideration of the matters herein recited, United Benefit does hereby

IN WITNESS WHEREOF, United Benefit has executed this Adoption and Ratification at ~~Omaha~~, Douglas County, Nebraska.

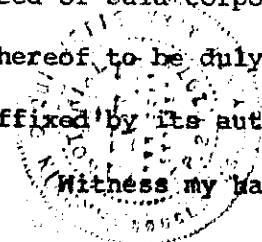
