WITNESSETH: THAT,

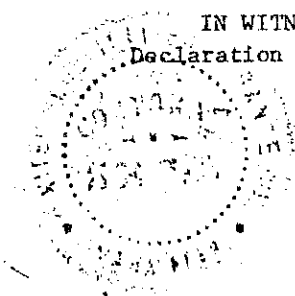
Whereas Declarant has heretofore executed a certain Supplementary Declaration on October 24, 1978, as recorded at Pages 387 through 391 at Book 609 of the Miscellaneous records of the Register of Deeds of Douglas County, Nebraska, containing an inadvertent error in the description of part of Lot 334, Regency 6th Addition, a subdivision in Douglas County, Nebraska, as surveyed, platted, and recorded, hereafter called "Regency 6",

Now, Therefore, in consideration of the matters herein recited and the acceptance of said Supplementary Declaration by Regency Homes Association, a Nebraska nonprofit corporation, hereafter called "Association", Declarant does hereby

CORRECT said Supplementary Declaration as follows, to-wit:

INVOLVED PROPERTY: That part of Paragraph 1 of said Supplementary Declaration describing the point of beginning of the strip on the northerly line of Lot 334 of Regency 6 is and will be from October 24, 1978, corrected so as to strike therefrom "179.03 feet" and substitute therefor "179.04 feet".
