**RELEASE** ~~AND QUITCLAIM~~ *LEW*

THIS RELEASE AND QUITCLAIM, Made this 26<sup>th</sup> day of June, 2006, by and between UNION PACIFIC RAILROAD COMPANY, a Delaware corporation, Grantor, and COURTLAND PLACE NO. 1, LLC, a Nebraska limited liability company, Grantee, WITNESSETH:

**RECITALS**

WHEREAS, by Quitclaim Deed last dated May 22, 2003, and recorded on May 22, 2003 in the Office of the Register of Deeds of Douglas County, Nebraska, in Book 2242, Page 619, as Deed No. 2003 07273, Grantor reserved unto itself, its successors and assigns, a perpetual easement for Fiber Optic Improvements upon, over and across certain lands in Douglas County, State of Nebraska, described in **Exhibit A** attached hereto and hereby made a part hereof; and

WHEREAS, by Quitclaim Deed last dated March 18, 2004, and recorded on March 23, 2004 in the Office of the Register of Deeds, Douglas County, Nebraska, as Deed No. 2004036435, Grantor reserved unto itself, its successors and assigns, a perpetual easement for Fiber Optic Improvements upon, over and across certain lands in Douglas County, State of Nebraska, described in **Exhibit B** attached hereto and hereby made a part hereof; and

WHEREAS, Grantee desires the cancellation and release of the easement rights granted to Grantor in the above-referenced Quitclaim Deeds, and Grantor is willing that such easement rights be cancelled and released.

NOW, THEREFORE, Grantor, in consideration of the premises and in consideration of the sum of One Dollar (\$1.00) to it in hand paid, the receipt of which is hereby confessed and acknowledged, for itself, its successors and assigns, does hereby REMISE, RELEASE AND QUITCLAIM to Grantee, its successors and assigns, forever, all of Grantor's right, title, interest, estate, claim and demand, both at law and in equity, which it has by reason of the above easements, it being the intent hereof to release only the right of Grantor with respect to

said easements, and to leave in full force and effect all other provisions of said Quitclaim Deeds, and all other rights reserved therein.

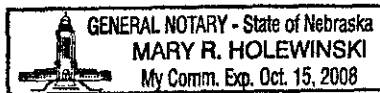
