

## CERTIFICATE OF AMENDMENT TO DECLARATION OF CONDOMINIUM

WHEREAS, the undersigned being the members of the executive board of the Southfork Condominium Association called a special meeting on June 15, 2009 concerning the declaration of condominium for units 1 through 12 inclusive of Southfork Condominiums located on Lot 24 Southfork Addition, City of Blair, Washington County, Nebraska.

WHEREAS said meeting was held pursuant to the terms of Chapter 76-854 Nebraska R.S.S. of which the provisions are hereby referenced and included herein and also pursuant to the terms and provisions of the By-Laws of Southfork Condominiums.

WHEREAS 12 of the 12 unit owners voted to amend the declaration of condominium filed April 26, 2000 in Record Book 316, Pages 607-616 and re-recorded November 15, 2000 in Record Book 326, Pages 256-271.

THEREFORE, said declaration of condominium is amended as follows, wherever Exhibit "A" appears in said declaration referred to therein is hereby replaced and superseded by the new Exhibit "A" included with this amendment and by this reference made a part hereof.

Item III, Paragraph A, sub-paragraph a) to be replaced and substituted with the following:

a) Two (2) buildings containing four (4) units each and two (2) buildings containing two (2) units each numbered unit 1 to 12 inclusive, #1 being on the south side of the south building and #12 being on the north side of the north building as shown on attached exhibit "A". The buildings have been constructed substantially as 2 four (4) unit and 2 two (2) unit one-story apartment buildings for and by the developers. Also on exhibit "A" is a plot plan and survey showing the location of the buildings and the remainder of the condominium property, although every other unit shown on building plans is mirrored.

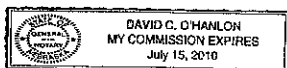
