## SOUTHFORK ADDITION TO CITY OF BLAIR

The following is a list of the exceptions, things to watch for when doing Southfork Addition to the City of Blair.

The first policy we did was on Lot 1, which came out of Tax Lot 187 in Section 14-18-11. The exceptions listed below are just the exceptions we had on the Lot 1 policy; exceptions may change depending on which lot we are doing. The master file contains searches on each Tax Lot that Southfork came out of, however only Tax Lot 187 was completely gone through; the other lots will need to be gone through before doing any lot that does not come out of Tax Lot 187.
