KNOW ALL MEN BY THESE PRESENTS: That NORTHERN NATURAL GAS COMPANY, Division of InterNorth, Inc., a Delaware Corporation, for and in consideration of the payment of the amount of One Dollar (\$1.00), the receipt of which is hereby acknowledged, does hereby GRANT, SELL, TRANSFER and CONVEY, as is, unto the METROPOLITAN UTILITIES DISTRICT, OMAHA, NEBRASKA, the following described property, as is:

One Pipeline, consisting of 3" pipe, approximately 600 feet in total length, abandoned in place, on the following described property: From 122nd Street in Signals Hills Subdivision in Northeast Quarter (NE-1) Section Seven (7), to a point 270 feet east of the center of 120th Street in Section Eight (8), Township Fourteen (14) North, Range Twelve (12) East, Douglas County, Nebraska.

Northern Natural Gas Company, Division of InterNorth, Inc., does hereby covenant with the Metropolitan Utilities District that it is the lawful owner of the 3" pipeline conveyed hereunder; that said pipeline is free from all encumbrances; that it has the right to sell the same as aforesaid; by its acceptance of this instrument and the said pipeline, the Metropolitan Utilities District does hereby assume, from and after the date hereof, all of the responsibilities and liabilities incident to the ownership of the 600 feet, more or less of 3" pipeline in Section 7 and Section 8, Township Fourteen (14) North, Range Twelve (12) East, Douglas County, Nebraska, which is this date abandoned in place to it.

THERE ARE, HOWEVER, NO OTHER WARRANTIES GIVEN BY VENDOR THAN HEREBY STATED.

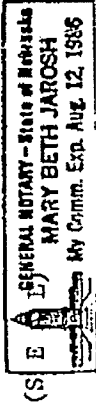
