

PARTIAL ASSIGNMENT OF EASEMENT

KNOW ALL MEN BY THESE PRESENTS:

That NORTHERN NATURAL GAS COMPANY, Division of InterNorth, Inc., a Delaware Corporation, having its principal place of business at 2223 Dodge Street, Omaha, Nebraska, herein called the "Assignor", for and in consideration of the sum of One Dollar (\$1.00) and other good and valuable consideration paid by Assignee, the receipt of which is hereby acknowledged, does hereby sell, assign, quitclaim and convey unto the METROPOLITAN UTILITIES DISTRICT, Omaha, Nebraska herein called the "Assignee", only so much of the right, title and interest of the Assignor in that certain easement dated September 11, 1958 from Max H. Speck and Esther C. Speck, husband and wife, as grantors, to Northern Natural Gas Company, as grantee and recorded in Book 335 at Page 117 of the Miscellaneous records at the Registrar of Deeds office, Douglas County Nebraska and that certain easement dated April 16, 1983 from Madeline Jacobsen Properties, Inc., as grantor, to Northern Natural Gas Company, grantee, and recorded in Book 398 at Page 677 of the Miscellaneous Records at the Registrar of Deeds office, Douglas County, Nebraska as pertains to the following described property:

From 122nd Street in Signal Hills/Subdivision in North-east Quarter (NE4) Section Seven (7), to a point 270 feet east of the center of 120th Street in Section Eight (8), Township Fourteen (14) North, Range Twelve (12) East, Douglas County, Nebraska.

And the said Metropolitan Utilities District, by the acceptance here does hereby covenant and agree to save and hold the said Northern Natural Gas Company, Division of InterNorth, Inc., harmless from any obligation, loss, liability or expense arising out of or in any manner attributable to the exercise by said Assignee of any rights under said easement grants from this day forward.
