DESCRIPTION

This plat known as "SOUTHPOINTE PAVILIONS FOURTH ADDITION", and as described in the certificate is made with the free consent and in accordance with the desires of the sole owners, and the easements shown thereon are hereby granted in perpetuity to the City of Lincoln, Nebraska, a municipal corporation, Allant Communications, Time Warner Entertainment - Lincoln, Lincoln Natural Gas, Lincoln Electric System, their successors and assigns, to allow for the purposes of construction, reconstruction, replacement, repair, operation and maintenance of poles, conduits, fixtures, poles, towers, pipes and equipment for the distribution of electricity, telephone and cable television; wastewater collectors; storm drains; water mains and all easements thereto, over, upon or under the easements as shown on the foregoing plat.

The erection or location of any building or structure, excluding fences, over, upon or under an easement shown thereon shall be prohibited.

The erection or location of any fence or other improvement which obstructs drainage shall be prohibited over, upon or under any storm drain easement or drainage easement shown thereon.

The City of Lincoln, Nebraska, its successors or assigns are hereby held harmless for the cost of any damage to any improvement or vegetation over, upon or under any easement shown thereon.

Any existing facilities shall be at the owner/developers expense.

The easements hereby granted over Lots 1 thru 4.

The easements hereby granted to Lot 2, Block 2, Southpointe Pavilions First Addition from Lots 3 and 4.

The parking easement hereby granted between Lots 2, 3 and 4.
