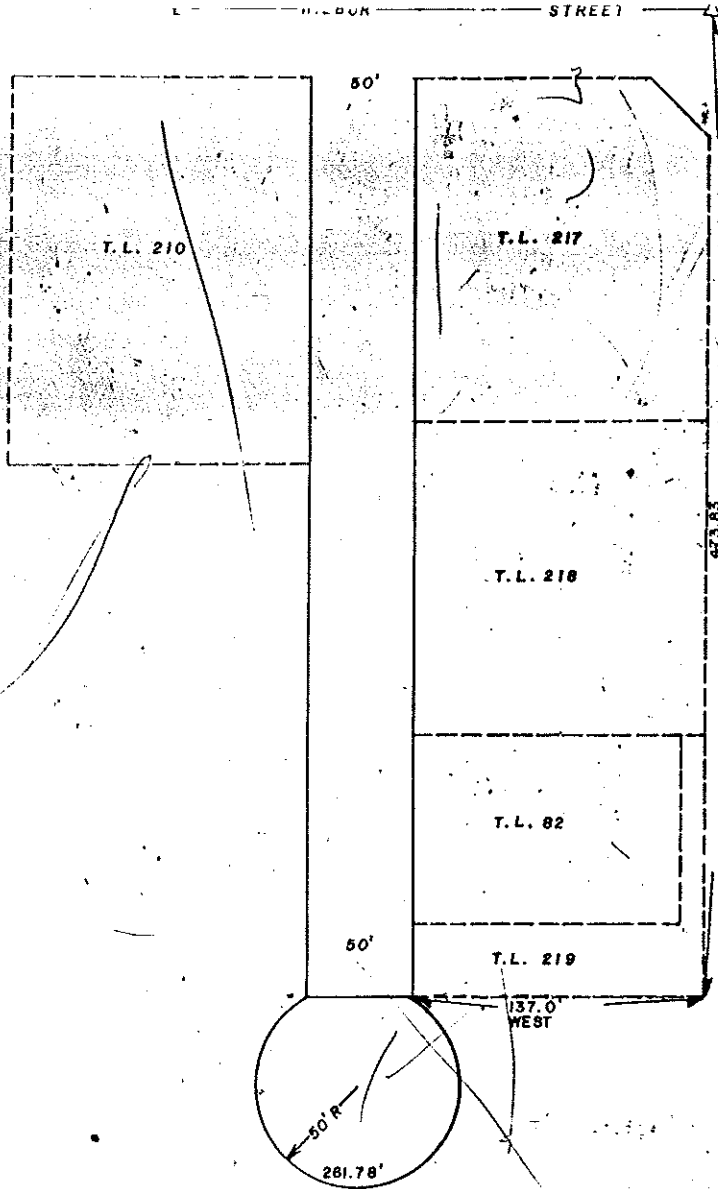


Dedication Plat



LEGAL DESCRIPTION

A 50 FOOT RADIUS CUL-DE-SAC LYING IN THE SOUTHWEST 1/4 OF THE NORTHWEST 1/4 OF SECTION 13, T-18-N, R-11-E OF THE 6TH P.M., WASHINGTON COUNTY NEBRASKA CONTAINING 0.18 ACRES MORE OR LESS MORE PARTICULARLY DESCRIBED AS FOLLOWS:
 COMMENCING AT THE NORTHEAST CORNER OF THE SOUTHWEST 1/4 OF THE NORTHWEST 1/4 AND ASSUMING THE EAST LINE OF SAID 1/4 1/4 TO BEAR SOUTH 0°06'-13" WEST; THENCE SOUTH 0°06'-13" WEST A DISTANCE OF 473.83 FEET. THENCE WEST A DISTANCE OF 137.0 FEET TO THE POINT OF BEGINNING; SAID POINT BEING ON A 50.0 FOOT RADIUS CUL-DE-SAC; THENCE ALONG SAID RADIUS CURVE TO THE RIGHT A DISTANCE OF 281.78 FEET; THENCE EAST A DISTANCE OF 50.0 FEET TO THE POINT OF BEGINNING.

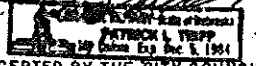
