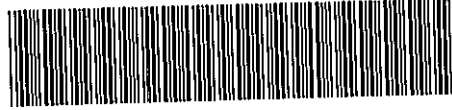

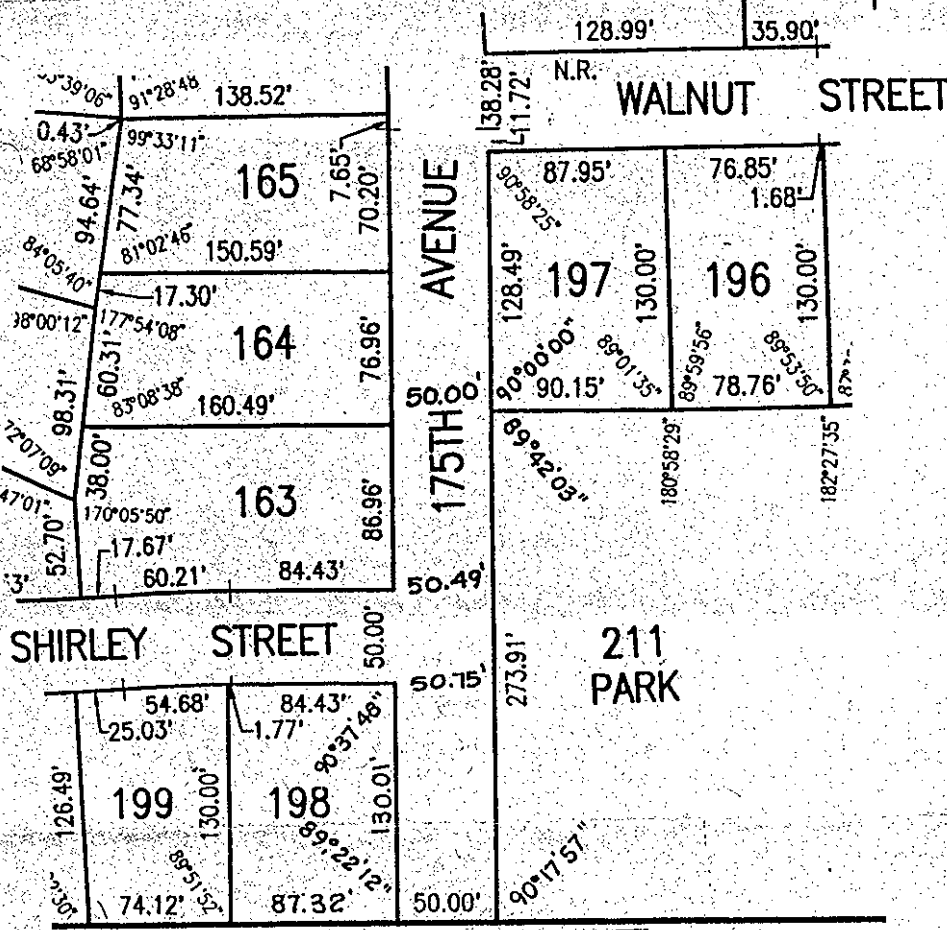

AFFIDAVIT OF CORRECTION

To correct certain right-of-way widths of 175th Avenue in Spring Ridge (lots 138 thru 211 inclusive), a subdivision located in the NW1/4 of Section 28, Township 15 North, Range 11 East of the 6th P.M., Douglas County, Nebraska.

The right-of-way width of 175th Avenue from the Northeast corner of Lot 198 said Spring Ridge (lots 138 thru 211 inclusive), perpendicular to the West line of Lot 211 said Spring Ridge (lots 138 thru 211 inclusive), should read 50.75 feet.

The right-of-way width of 175th Avenue from the Southeast corner of Lot 163 said Spring Ridge (lots 138 thru 211 inclusive), perpendicular to the West line of said Lot 211, Spring Ridge (lots 138 thru 211 inclusive), should read 50.49 feet.

The right-of-way width of 175th Avenue from the Southwest corner of Lot 197 said Spring Ridge (lots 138 thru 211 inclusive), perpendicular to the East line of Lot 164 said Spring Ridge (lots 138 thru 211 inclusive), should read 50.00 feet.

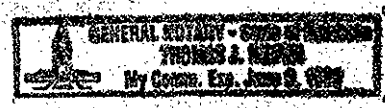
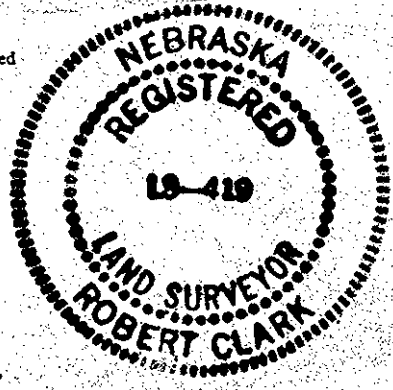
