RESOLUTION TO CHANGE A STREET NAME  
IN A SUBDIVISION KNOWN AS SPRINGHILL ADDITION

WHEREAS, pursuant to Neb. Rev. Stat. § 23-104(6) (Reissue 1997), Sarpy County has the power to do all acts in relation to the concerns of the County necessary to the exercise of its corporate powers; and,

WHEREAS, pursuant to Neb. Rev. Stat. § 23-103 (Reissue 1997), the powers of a County as a body are exercised by the County Board; and,

WHEREAS, Boyer Young Equities III LLC has requested a name change of a street in Springhill Addition, Sarpy County, Nebraska from "South 162<sup>nd</sup> Street" to "South 161<sup>st</sup> Terrace"; and,

WHEREAS, changing said street name will provide for orderly and proper growth and subdivision development, and will reduce confusion regarding street names and locations within Sarpy County, as well as aid in response time for emergency services in Sarpy County;

NOW, THEREFORE, BE IT RESOLVED BY THE SARPY COUNTY BOARD OF COMMISSIONERS THAT the name "South 162<sup>nd</sup> Street" shall be changed to "South 161<sup>st</sup> Terrace" in the subdivision known as Springhill Addition in Sarpy County, Nebraska., as shown on Exhibit "A" attached hereto.

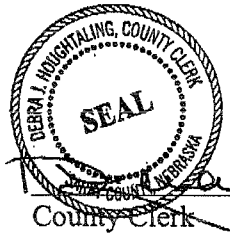

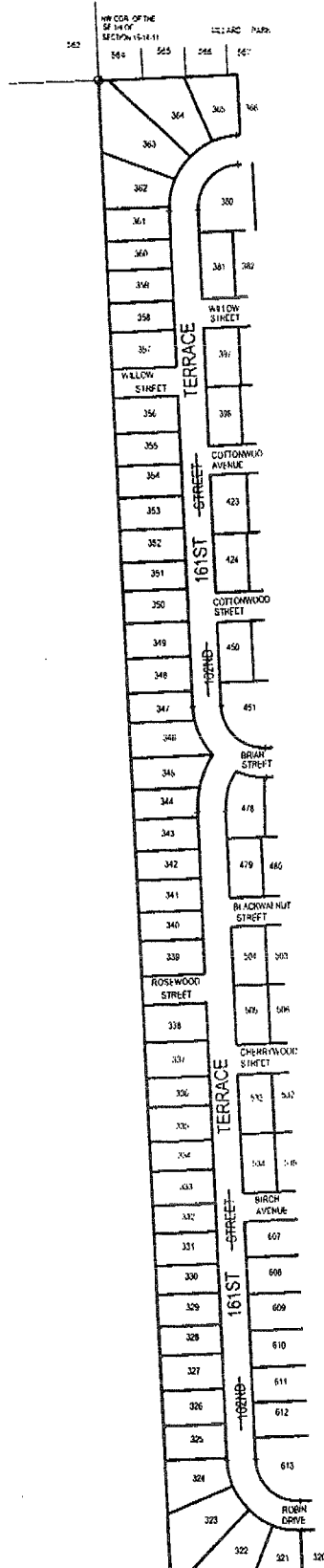
