PUBLIC ACCESS EASEMENT

Tyler Revocable Trust dated March 9, 2007 (collectively "Grantors"), record owners of the real property hereinafter described, hereby grant an unrestricted permanent easement and right to the City of Lincoln, Nebraska, a municipal corporation ("City"), to the public generally, and to the owners of Lots 1, 2 and 3, Stevens Creek Ridge Addition, and Lots 1 through 5, Block 1, and Outlot A, Stevens Creek Ridge First Addition, all located in Lincoln, Lancaster County, Nebraska, for the public use for vehicular and pedestrian purposes, over and through the real property described as the west sixty feet (60') of Lot 5, Block 1, Stevens Creek Ridge First Addition, Lincoln, Lancaster County, Nebraska (the "Easement Premises").

The City and the public generally shall have no duty or responsibility to construct, maintain and repair the Easement Premises by reason of its benefits from this Public Access Easement.

This conveyance is made with the free consent and in accordance with the desire of the Grantors, and the Easement Premises are hereby conveyed to allow for use by the public for vehicular and pedestrian use. Grantors covenant that they are the owners of the Easement Premises, that the Easement Premises are free and clear of any liens, and that they have legal right, title and capacity to grant the ingress and egress easement granted herein.
