AMENDMENT TO THE DECLARATION OF THE STONY BROOK VILLAS

THIS AMENDMENT TO THE DECLARATION filed July 18, 2003 as Instrument No. 2003-137847 in the Office of the Register of Deeds, Douglas County, Nebraska ("Declaration") is herein referred to as the "Amendment" and dated the day of day of day of the Stony Brook Villas and members of the Stony Brook Villas Homeowners Association. ("Association").

RECITALS OF FACT

The Association and the undersigned Lot Owners govern the real property described as

Lots 1 through 39, Stony Brook Villas, Douglas County, Nebraska

The Lot Owners desire to limit rental of the Lots in the Stony Brook Villas subdivision. "Rental" shall mean allowing occupation of any dwelling on a Lot by those who are not Lot Owners or owners of entities owning Lots and for payment of valuable consideration.

WHEREAS Article IX, Section 3, of the Declaration states that the Declaration may be amended by recording a written, signed instrument by 75% of the Lot Owners and upon recording such instrument in the Office of the Register of Deeds of Douglas County, Nebraska.

WHEREAS, the undersigned represent 75% or more of Lot Owners in favor of the Amendment to limit rental of dwellings on Lots.

AMENDMENT

For the reasons stated above, the undersigned hereby amend the Declaration as follows and all of such amendments shall supersede any inconsistent provisions in the Declaration.

Effective Date of Amendment. This Amendment shall become effective as of the date of the signing of this instrument by 75% of the Lot Owners and filing with the Douglas County Register of Deeds of Douglas County Nebraska.

<u>Limitation on Rental of Lots.</u> Except for existing rentals, no Lot may be rented or occupied for money for any period of time. The purpose of this restriction is to encourage owner occupancy

and increase property upkeep and values. Once tenants from any current rentals no longer occupy a Lot, each such Lot can no longer be rented and shall be owner occupied.

Enforcement and Fines. The Board, Association or Lot Owners may enforce compliance of this Amendment at law or in equity. Further, the Board or Association may enforce compliance at law or in equity for any violation of the Declaration of Covenants, Bylaws of the Association or any reasonable rules and regulations passed by the Board or the Association. Without limitation, the Board or Association may enforce compliance by injunctive relief and by imposing reasonable fines. If fines are imposed, they may be treated as assessments and enforced the same as assessments under the Declaration of Covenants.

ARTICLE IX, Section 4 "Term" of the Declaration is amended and restated to read as follows:

Section 4. Term. The covenants and restrictions contained in this Declaration shall run with the land and shall be binding on all Lots until at least 75% of Lot Owners shall sign a written instrument terminating the Declaration which shall be effective upon recording such written termination with the Douglas County Register of Deeds.
