STONYBROOK SOUTH RESTRICTIVE COVENANTS
FIRST AMENDMENT

The undersigned hereby declare that the following First Amendment to the restrictive covenants shall become operative on August 1, 2019 and are to run with the land and shall be binding on all present and future owners of all or any part of the following described real estate.

All lots in STONYBROOK SOUTH, an Addition in Sarpy County Nebraska, as surveyed, platted and recorded, which are listed on Exhibit "A", attached hereto and incorporated by a reference.

SECTION I: PURPOSE

The restrictive covenants described herein are for the purpose of ensuring that all lot improvements and maintenance conform to the harmony of design and location in relation to surrounding structures, to protect the value, character, and residential quality of all lots in the neighborhood, as well as the quiet enjoyment of property by the residents of the neighborhood.

SECTION II: ENFORCEMENT

Any present or future owner or owners of any part of any lot may prosecute any proceedings at law or in equity against the person or persons violating or attempting to violate any of these covenants in order to prevent, halt, or abate such violation, and to recover damages for such violation.

SECTION III: LOT, STRUCTURE, AND IMPROVEMENT GUIDELINES

- A. All lots shall be used only for single-family residence purposes.
- B. No lot shall be re-subdivided into two or more smaller lots unless each dwelling site resulting from lost-splitting contains at least as much area as the smallest lot in Stonybrook South Addition.
- C. All dwelling shall be constructed to have garage space for at least two automobiles.
- D. No trailer, basement, tent, shack, garage, barn, or other outbuilding erected on said real estate shall be used as a residence temporarily or permanently, nor shall any structure of a temporary character be used as a residence.
- E. Dwellings constructed in another addition or location shall not be moved to any lot within the Addition.
- F. No building or other materials shall be placed on any lot until construction is started on any approved structure or other improvement.
- G. No fence, screen wall, or similar structure shall be erected unless written approval is obtained in advance from the Architectural Committee.
- H. No alterations to dwelling or structures may be erected without approval from the Architectural Committee in advance, other than routine maintenance.

SECTION IV: NUSIANCES

- A. No noxious or offensive trade or activity shall be carried on upon any lot or property in the neighborhood.
- B. Property of any description within the neighborhood shall not be used in any way so as to endanger the health of any person or unreasonably disturb the owner or owners of any person or the neighborhood.
- C. All lots shall be kept free of trash and debris.
- D. No garbage or trash can or accumulations of trash shall be permitted outside dwellings except as screened from view.
- E. No incinerator or trash burner shall be permitted on any lot unless the same is incorporated into the dwelling and not exposed to view from the outside of the dwelling.
- F. All residential lots, including the premises, structures, fencing, and other improvements shall be adequately maintained so as to not present a deteriorated or blighted appearance.

SECTION V: ANIMALS

- A. No animals, horses, or other livestock or poultry of any kind shall be raised or kept on any property in the neighborhood, except household pets.
- B. Dogs, cats, or other household pets are permitted, provided they are not kept, bred, or maintained for any commercial purpose.
- C. Household pets shall be kept confined to the lot of the owner and are not permitted to run loose in the Addition.

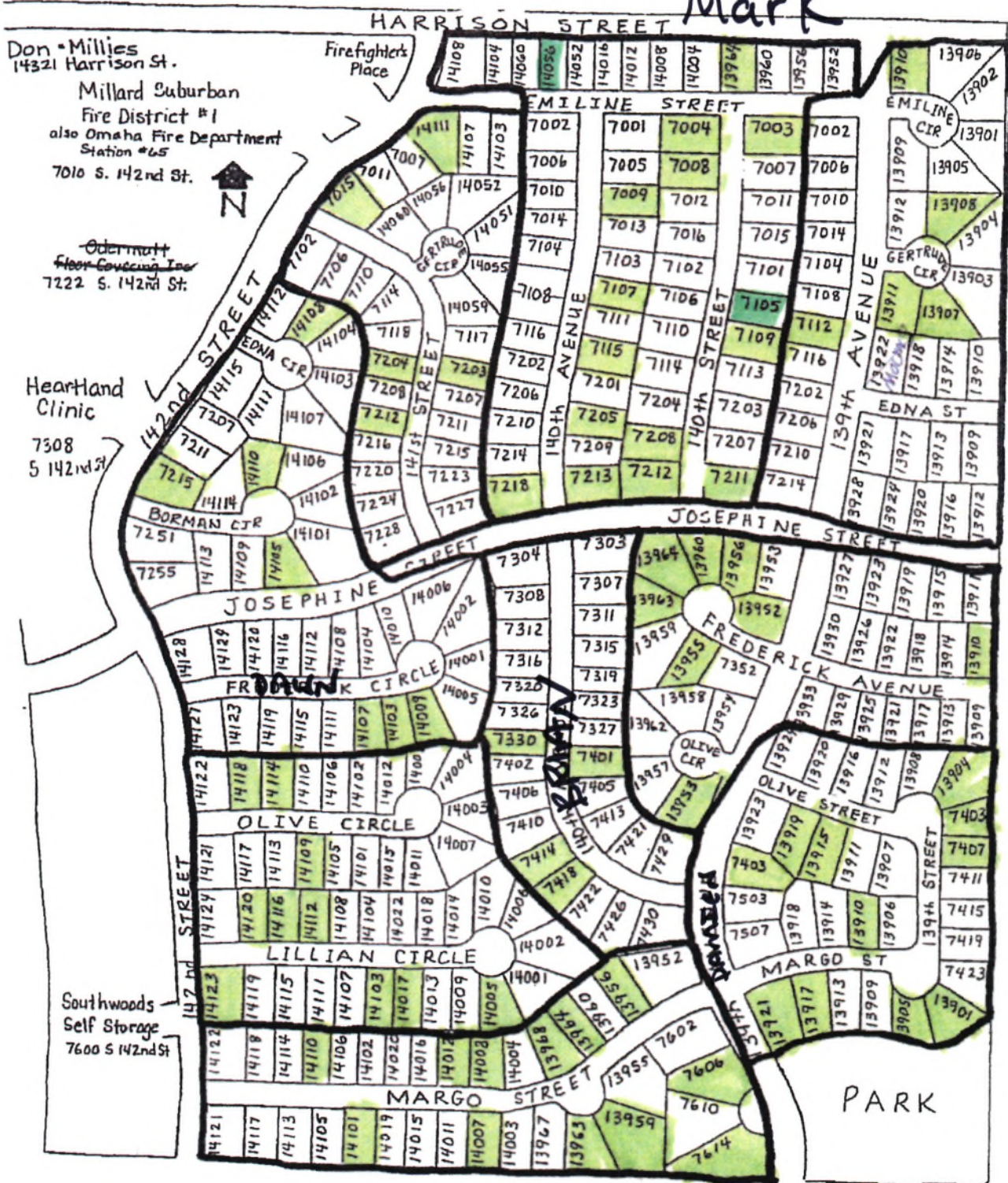
SECTION VI: VEHICLES AND PARKING

- A. Motor Vehicles parked out-of-doors within the subdivision or upon its streets must be in operating condition.
- B. Parking of motorized vehicles on grass surfaces is prohibited, and all such vehicles parked outside must be on an approved hard surfaced slab or drive.
- C. Repair work on motor vehicles, boats, motorcycles, trucks, campers, recreational vehicles, or similar vehicles lasting longer than 48 hours must be done indoors.
- D. Boats, campers, recreational vehicles of any type, or trailers must be parked or stored indoors.
- E. No vehicle, boat, camper, trailer, or recreational vehicle of any type shall be parked in the right-of-way located between the pavement and the lot line of each residential lot.

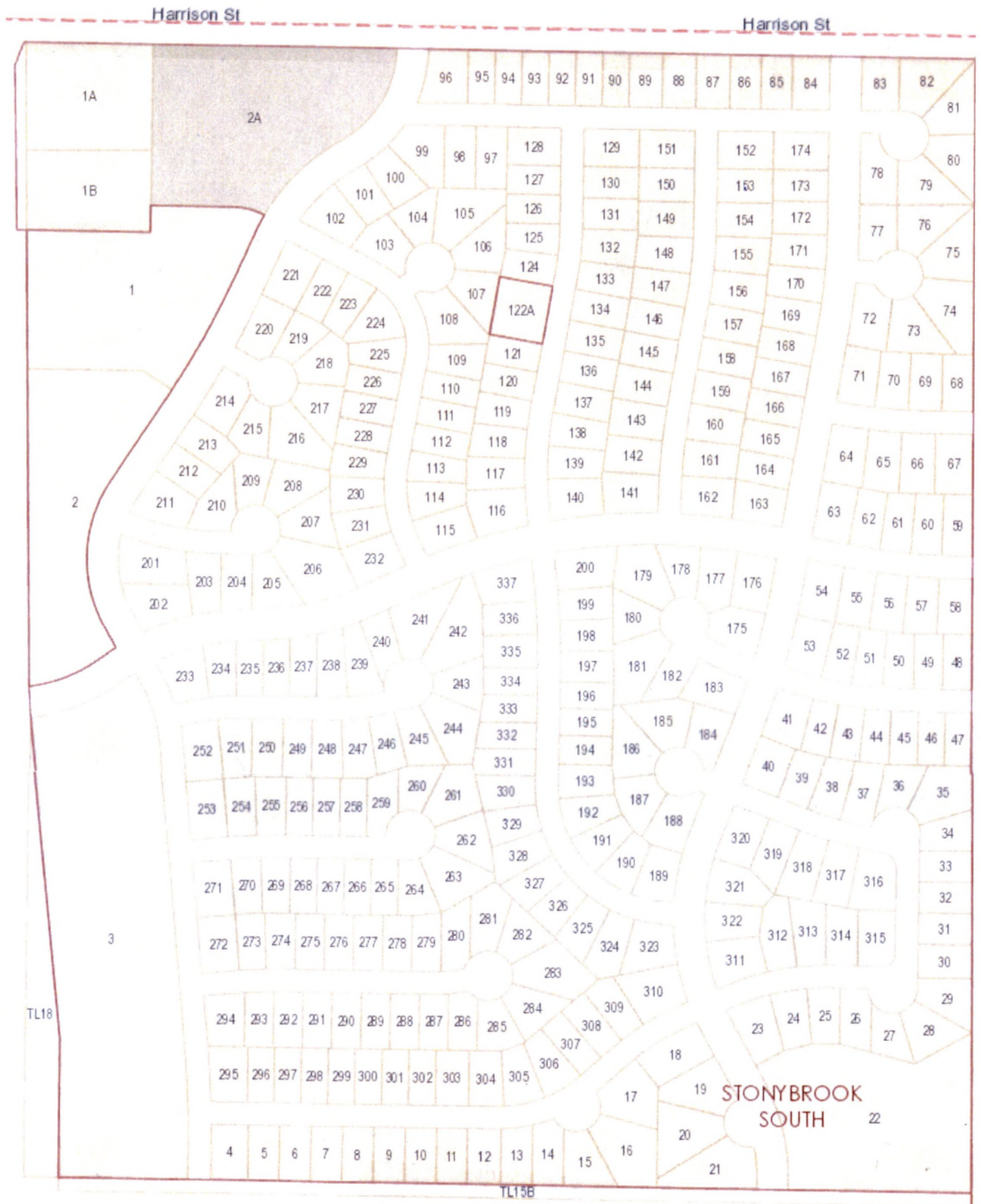
SECTION VII: MISCELLANEOUS

- A. No outside radio, television or other electronic antenna or aerial shall be erected on any lot without written consent of the Architectural Committee.
- B. No posters or advertising signs of any kinds shall be erected on any lot and remain longer than 48 hours within any thirty (30) day period, unless approved by the Architectural Committee in advance. This restriction shall not apply to residential "For Sale" signs, or signs related to construction and improvements of lots during the time that construction or improvements are in progress.

RESTRICTIVE COVENANTS

The undersigned hereby declare that the following covenants shall become operative on August 1, 1989, and are to run with the land and shall be binding on all present and future owners of all or any part of the following described real estate for thirty (30) years from the date thereof, unless extended as hereinafter provided:

All lots in STONYBROOK SOUTH, an Addition in Sarpy County, Nebraska, as surveyed, platted and recorded, which are listed on Exhibit "A", attached hereunto and incorporated by reference.

If the present or future owners of any said lots shall violate or attempt to violate any of these covenants, it shall be lawful for any other persons owning any part of said real estate to prosecute any proceedings at law or in equity against the person or persons violating or attempting to violate any such covenants and either prevent him or them from so doing, or to recover damages for such violation.

Invalidation of any of these covenants by judgment or court order shall in no way affect any of the other provisions hereof which shall remain in full force and effect.

- A) All lots shall be used for single-family residence purposes or for park, library, or school purposes. The construction of model homes and the use of same by the developers during the development of Stonybrook South shall not be deemed to violate this or any other provision of these covenants.
- B) No noxious or offensive trade or activity shall be carried on upon any plot nor shall anything be done thereon which may be or become an annoyance, or nuisance to the neighborhood. All lots shall be kept free of trash and debris.
- C) No trailer, basement, tent, shack, garage, barn, or other outbuilding erected on said real estate shall at any time be used as a residence temporarily or permanently, nor shall any structure of a temporary character be used as a residence. No animals, horses or other livestock or poultry of any kind shall be raised or kept on said real estate, except that dogs, cats, or other household pets are permitted, provided they are not kept, bred, or maintained for any commercial purpose, and provided that they are kept confined to the lot of the owner and are not permitted to run loose in the Addition. Dwellings constructed in another addition of location shall not be moved to any lot within this Addition. No outside radio, television, or other electronic antenna or aerial shall be erected on any building lot without the written consent of the Architectural Committee. No posters or advertising signs of any kind (except residential "For Sale" signs, not exceeding 2 foot by 2 foot (2' x 2') in size) shall be erected on any building plot. The above restriction as to signs does not apply to signs erected by the developers or their agents, in the development of the subdivisions.

- D) No fences or screen walls shall be erected unless written approval therefore is obtained from the Architectural Committee
- E) No building materials shall be placed on any lot until construction is started on the main residential structure.
- F) No alterations to a dwelling or structures may be erected without approval from the Architectural Committee.
- G) No dwelling shall have garage space for less than two automobiles. Automobiles parked out-of-doors within the subdivision or upon its streets must be in operating condition or else said cars may be towed away at the owner's expense upon the request or act of any landowner in the subdivision. All automobiles must be parked either indoors or on a hard surfaced slabs or drives, if parked out-of-doors. All repair work on automobiles must be done indoors. All boats, campers, or trailers, must be parted or stored indoors so as not to be visible from the outside. The dedicated street right-of-way located between the pavement and the lot line of each residential zoned lot, shall not be used for the parking of any private or commercial vehicles or boats, campers, or trailers or recreational vehicles. No incinerator or trash burner shall be permitted on an lot unless the same is incorporated into the swelling and not exposed to view from the outside of the dwelling.
- H) No garbage or trash can or accumulations of trash shall be permitted outside the dwellings except as screened from view.
- I) All plans and specifications for residential construction shall be submitted to the Architectural Review Committee for approval as to front, side, and rear yard setbacks, exterior design; use of exterior materials; placement of house on lot; drainage; and required minimum enclosed and finished living space. In no event will any construction begin or any structure be erected or permitted to remain on any lot until the above matters have been submitted to and approved by the Architectural Review Committee. Plans and specifications for the initial construction of residences with at least 1,400 square feet (main floor and above) finished living space, brick covered front elevation foundations, and roof styles other than flat or mansard are not subject to Architectural Review Committee approval under this paragraph.
- J) None of said lots shall be re-subdivided into two or more smaller lots unless each dwelling site resulting from lot-splitting contains at least as much area as the smallest lot in Stonybrook South Addition.
- K) A set of plans and specifications must be submitted and approved by the Architectural Committee and kept on file for each dwelling except for the dwellings which meet the minimum provisions of paragraph I above.

- L) The Architectural Committee or Architectural Review Committee as referred to above shall be such committee designated by Stonybrook South Homeowners Association, consisting of not less than two, or more than five, members.

The foregoing covenants may be amended or extended for additional periods by an instrument signed by the owners of not less than seventy-five (75) percent of the lots then covered by these covenants.

- L. The Architecture Committee or Architectural Review Committee as referred to above shall be such committee designated by Stonybrook South Homeowners Association, consisting of not less than two or more than five members.


The foregoing covenants may be amended or extended for additional periods by an instrument signed by the owners of not less than seventy-five (75%) of the Lots then covered by these covenants.



Thereafter, additional owners may subject their lots to the mutual benefits and restrictions of these covenants by signing and acknowledging a written instrument indicating such intent and agreement, and upon recording thereof, it shall have the same force and effect as if they had signed and acknowledged these Restrictive Covenants.

L. The Architecture Committee or Architectural Review Committee as referred to above shall be such committee designated by Freeman Co., Inc., consisting of not less than two or more than five members.
