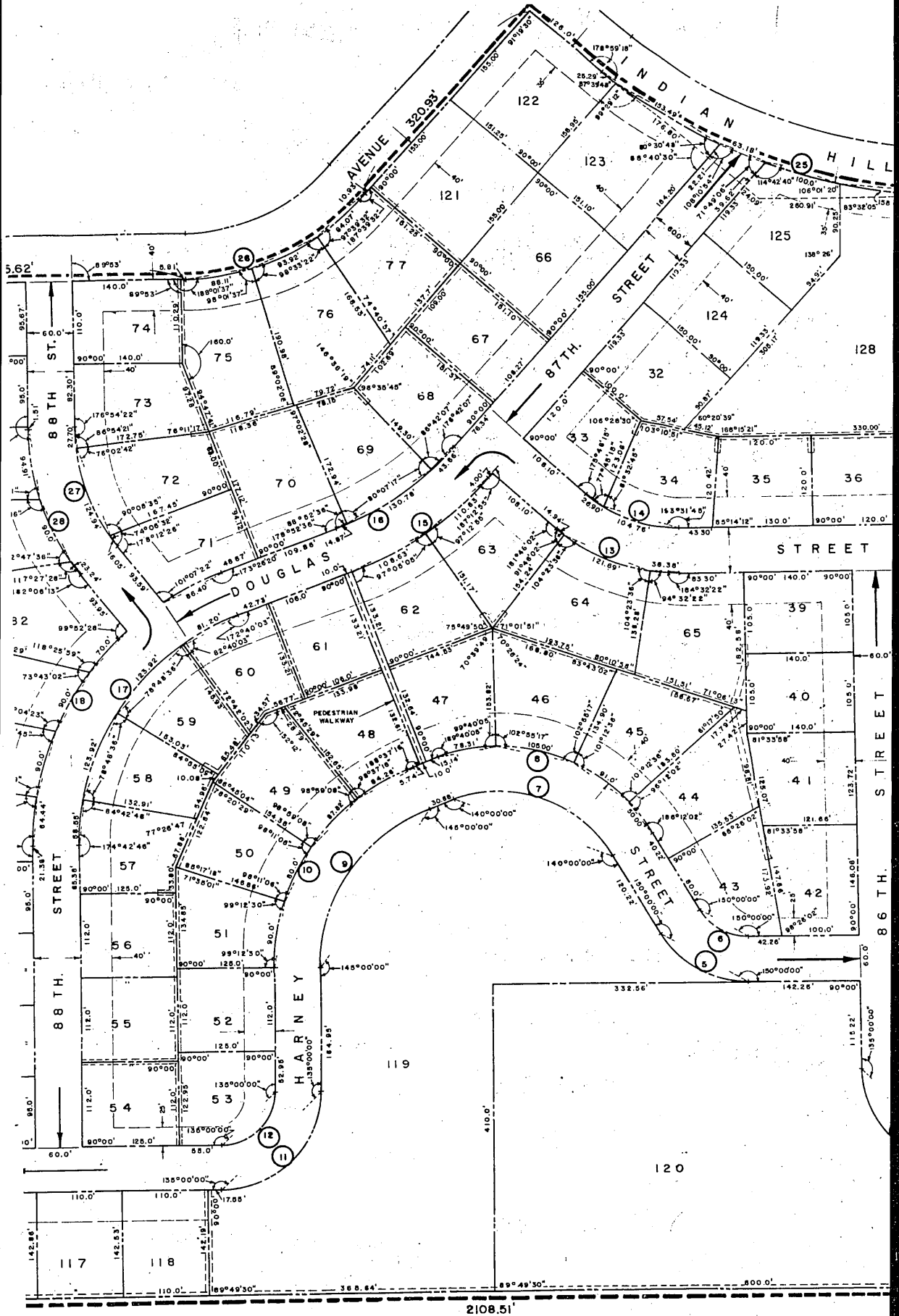

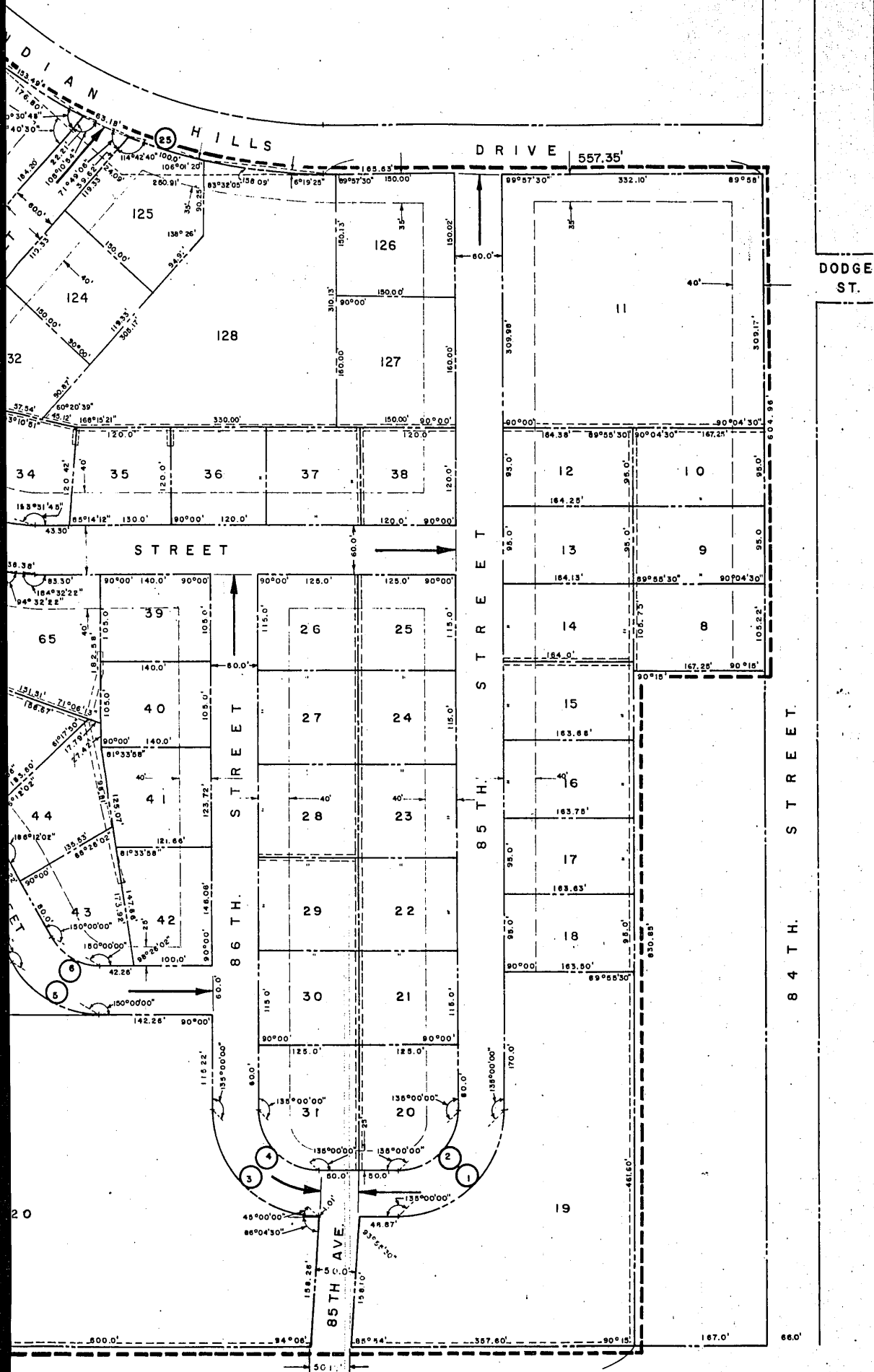
POINT OF BEGINNING

THE SURVEYOR'S CERTIFICATE

1. I hereby certify that: I have accurately surveyed and staked with iron pipe all corners of all lots, streets, angle points and the ends of all curves in Indian Hills Village.
2. That said Indian Hills Village is a plat of a tract of land in the Northeast Quarter (N.E. 1/4) of Section Twenty-two (22), Township Fifteen (15) North, Range Twelve (12) East of the Sixth Principal Meridian, in Douglas County, Nebraska, being more particularly described as follows:

Beginning at a point on the South line of the N.E. 1/4 of said Section 22, T. 15 N., R. 12 E., said point being N. 89°49'30" E. 330.00 feet from the center of said Section 22, thence due North 1322.65 feet; thence N. 89°53' E. 150.05 feet; thence due North 21.40 feet; thence No. 89°53' E. 565.62 feet; thence Northeasterly 266.10 feet along a circular arc whose radius is 314.46 feet and whose chord bearing and length are N. 65°38'30" E. and 258.23 feet respectively; thence N. 41°24' E. 320.93 feet; thence S. 49°55'30" E. 126.00 feet; thence Southeasterly 500.42 feet along a circular arc whose radius is 716.20 feet and whose chord bearing and length are S. 69°56'30" E. and 490.30 feet respectively; thence S. 89°57'30" E. 557.35 feet to a point on the West line of 84th Street; thence S. 0°04'30" W. 604.96 feet along said West line of 84th Street; thence S. 89°49'30" W. 166.94 feet; thence S. 0°04'30" W. 830.85 feet to a point on the South line of said N.E. 1/4, Section 22; thence S. 89°49'30" W. 2108.51 feet along said South line of said N.E. 1/4, Section 22, to the point of beginning containing 71.5 acres, more or less.

In this description, the centerline of 90th Street (West line of N.E. 1/4, Section 22) is assumed to be true North and South.
