

It is agreed between the undersigned parties as follows:

1. Omaha Public Power District is the owner and holder of an easement over portions of Lots Eight (8) to Fourteen (14) inclusive and Lots Thirty-eight (38) and One Hundred Twenty-seven (127) in Indian Hills Village in Douglas County, Nebraska, as indicated on the recorded plat of said Addition as recorded in Deed Book 1049 at Page 188 in the Register of Deeds Office of said County.

2. Cecil A. Johnson, Trustee, is the owner of Lot Eight (8) in Indian Hills Village in Douglas County, Nebraska.

3. The W. Clarke Swanson Family Real Estate Partnership is the owner of Lot Eleven (11) in Indian Hills Village in Douglas County, Nebraska.

4. It is mutually agreed between the undersigned parties that:

A. Omaha Public Power District hereby releases their easements as granted over the North and East five (5) feet of Lot Twelve (12), the South five (5) feet of Lot Eleven (11), the West five (5) feet of Lots Ten (10) and Nine (9), the East five (5) feet of Lot Thirteen (13), the East five (5) feet of the North fifty-five (55) feet of Lot Fourteen (14), the West five (5) feet of the North fifty-five (55) feet of Lot Eight (8), the North five (5) feet of the East eighty (80) feet of Lot Thirty-eight (38), and the South five (5) feet of the East eighty (80) feet of Lot One Hundred Twenty-seven (127) all in Indian Hills Village.

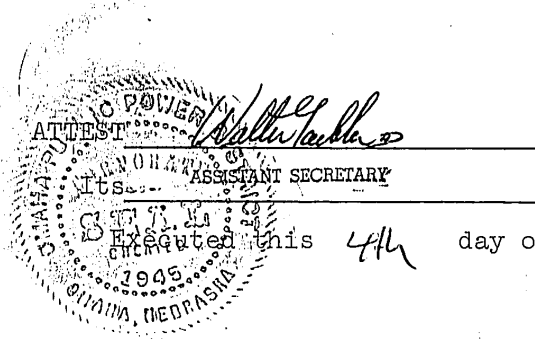
B. Omaha Public Power District hereby releases their overhead easement rights over the North five (5) feet of Lot Ten (10), but does specifically reserve all underground easement rights they have over the North five (5) feet of the East one hundred thirty-two and twenty-five hundredths (132.25) feet of said Lot Ten (10) in Indian Hills Village.

C. Cecil A. Johnson, Trustee, hereby grants to Omaha Public Power District, their successors and assigns, a perpetual easement to install and maintain underground distribution facilities over the South ten (10) feet of Lot Eight (8) in Indian Hills Village.

D. The W. Clarke Swanson Family Real Estate Partnership hereby grants to Omaha Public Power District, their successors and assigns, a perpetual easement to install and maintain underground distribution facilities over the South ten (10) feet of the East one hundred thirty-two and twenty-five hundredths (132.25) feet of Lot Eleven (11) in Indian Hills Village.

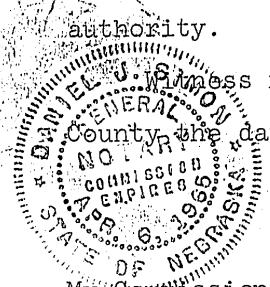

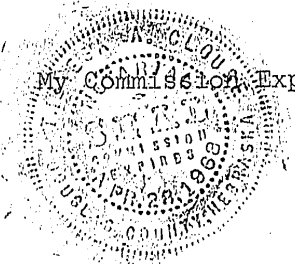
