- 1. Omaha Public Power District is the owner and holder of an easement over portions of Lots Eight (8) to Fourteen (14) inclusive and Lots Thirty-eight (38) and One Hundred Twenty-seven (127) in Indian Hills Village in Douglas County, Nebraska, as indicated on the recorded plat of said Addition as recorded in Deed Book 1049 at Page 188 in the Register of Deeds Office of said County.
- 2. Cecil A. Johnson, Trustee, is the owner of Lot Eight (8) in Indian Hills Village in Douglas County, Nebraska.

Clarke Swanson Family Real Estate Partnership hereby grants to Omaha Public Power District, their successors and assigns, a perpetual easement to install and maintain underground distribution facilities over the South ten (10) feet of the East one hundred thirty-two and twenty-five hundredths (132.25) feet of Lot Eleven (11) in Indian Hills Village.
