FOR VALUABLE CONSIDERATION, NORTHERN NATURAL GAS COMPANY, Division of Enron Corp., a Delaware corporation (hereinafter referred to as "Assignor"), does hereby quitclaim, sell, grant, and assign unto PEOPLES NATURAL GAS COMPANY, Division of UtiliCorp United Inc. The Assignee, by the acceptance hereof, does hereby covenant and agree to save and hold the Assignor harmless from and against any loss, liability, or expense arising out of or in any manner attributable to the exercise by said Assignee of any rights under said Easements granted from this day forward.

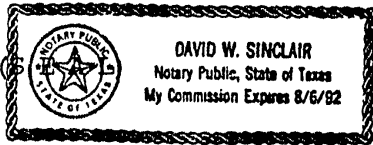

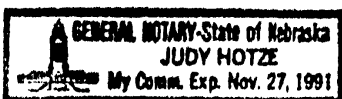
