

## RELINQUISHMENT

KNOW ALL MEN BY THESE PRESENTS:

That THE STATE OF NEBRASKA, Department of Roads, pursuant to the provisions of Statute Nos. 39-1313, 39-1314, of Revised Statutes of Nebraska, (Cum. Supp. 1955) does hereby relinquish, subject to the reservations and conditions hereinafter set forth, to the County of Douglas, the following described realty, situated in the County of Douglas, Nebraska, to-wit:

A strip of roadway lying over and across the Southwest Quarter of Section 4, Township 15 North, Range 12 East of the 6th P.M., Douglas County, Nebraska, described as follows:

Referring to the Southwest Corner of said Southwest Quarter; thence easterly along the South Line of said Southwest Quarter a distance of 1029.5 feet to point of beginning; thence northwesterly 143 degrees 03 minutes left a distance of 1288.2 feet; thence northerly 36 degrees 57 minutes right along the West Line of said Southwest Quarter a distance of 74.3 feet; thence easterly 90 degrees 00 minutes right a distance of 11.0 feet; thence southeasterly 36 degrees 57 minutes right a distance of 1383.6 feet; thence southeasterly along a 606.7 foot radius curve to the right a distance of 29.6 feet to the South Line of said Southwest Quarter; thence westerly along said South Line a distance of 109.8 feet to point of beginning.

The above described strip of roadway contains 2.08 acres, more or less.
