

RELINQUISHMENT

KNOW ALL MEN BY THESE PRESENTS:

That THE STATE OF NEBRASKA, Department of Roads, pursuant to the provisions of Statute Nos. 39-1313, 39-1314, of Revised Statutes of Nebraska, (Cum. Supp. 1955) does hereby relinquish, subject to the reservations and conditions hereinafter set forth, to the County of Douglas, the following described realty, situated in the County of Douglas, Nebraska, to-wit:

A strip of roadway lying over and across the Southeast Quarter of Section 5, Township 15 North, Range 12 East of the 6th P.M., Douglas County, Nebraska, described as follows:

Referring to the Southeast Corner of said Southeast Quarter; thence northerly along the East Line of said Southeast Quarter a distance of 774.4 feet to point of beginning; thence continuing northerly along said East Line a distance of 74.3 feet; thence westerly 90 degrees 00 minutes left a distance of 1574.5 feet; thence northwesterly 10 degrees 00 minutes right a distance of 1088.6 feet; thence southerly 100 degrees 00 minutes left along the West Line of said Southeast Quarter a distance of 69.9 feet; thence northeasterly 114 degrees 00 minutes left a distance of 5.2 feet; thence southeasterly 34 degrees 00 minutes right a distance of 1076.4 feet; thence easterly 10 degrees 00 minutes left a distance of 1569.3 feet thence southeasterly 36 degrees 57 minutes right a distance of 13.8 feet to point of beginning.

The above described strip of roadway contains 4.04 acres, more or less.
