

N O T I C E

TO WHOM IT MAY CONCERN:

Notice is hereby given as follows:

- 1 - That the City of Millard has installed a sewer main in Jackson Street from Oak Lane to a point 125 feet East of the East right-of-way line of Linden Street in Millard, Nebraska and that said sewer abutts on the lots or parcels of land described as follows:

Lots 67, 68, 69, 74, 414, 412, 413, 433 and 434, all in the Oaks, a subdivision in Douglas County, Nebraska.
- 2 - That such sewer was constructed in what is now the right-of-way line of Jackson Street, under and pursuant to the provisions of a certain easement and agreement recorded in Book 371, Miscellaneous Records, at Page 91.
- 3 - That all owners of the above-described property are hereby advised that at such time as any owners of any such property desire to connect to said sewer main, said owner will be required to pay the City of Millard any connection fees and use fees as may be then in force and as determined from time to time by the Mayor and City Council of such city and in addition thereto, a charge for the construction cost of such sewer main at the rate of \$2.75 per front footage abutting on the sewer main will be made as to each of said lots or parcels of land whose owners apply for and receive service from such mains; that the purpose of this construction charge is to reimburse the City of Millard for the money it spent in constructing said sewer main.

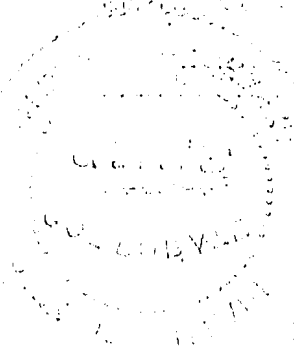
