

AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS, RESTRICTIONS AND EASEMENTS FOR THE VILLAS OF LINDEN ESTATES, A SUBDIVISION IN DOUGLAS COUNTY, NEBRASKA

This AMENDMENT is made this 29th day of May, 2008 to the Declaration of Covenants, Conditions, Restrictions and Easements for The Villas of Linden Estates, a Subdivision in Douglas County, Nebraska recorded with the Douglas County Register of Deeds on February 23, 1999, Miscellaneous Records, in Book 1282 at Page 661 (the "Declaration"), by at least seventy-five percent (75%) of the record owners of real estate subject to the Declaration (the "Owners").

PRELIMINARY STATEMENT

The Declaration is recorded against and governs the following real estate:

** FILED: AS IS

Lots 1 through 25, including, in The Villas at Linden Estates, a subdivision, as surveyed, platted and recorded in Douglas County, Nebraska.

(the "Properties").

Article IV, Paragraph 2 of the Declaration provides that "this Declaration may be amended by an instrument signed by the Owners of not less than seventy-five percent (75%) of the Lots covered by this Declaration." The Owners hereby amend the Declaration as follows:

1. The first sentence of Article I, Paragraph 2 of the Declaration is hereby deleted in its entirety and replaced as follows:

No residence, building, fence, wall, driveway, patio, patio enclosure, swimming pool, dog house, pool house, solar heating or cooling device, or other external improvement, above or below the ground (herein all referred to as any "Improvement") shall be constructed, erected, placed or permitted to remain on any Lot, nor shall any grading or excavation for any Improvement be commenced,

except for Improvements which have been approved by Declarant as follows:

2. Article I, Paragraph 6 of the Declaration is hereby deleted in its entirety and replaced as follows:

No exterior television or radio antenna of any sort shall be permitted on any Lot. No tree houses, tool sheds, doll houses, windmills, or similar structures shall be permitted on any lot without written consent of the Board of Directors of the Association (as defined in Article III of the Declaration). Also subject to the approval of the Board of Directors of the Association, an Owner may place one (1) satellite receiving station or "disc" on such Owner's Lot. The "disc" must be no more than twenty (20) inches in diameter and must be shielded from public view. Likewise, subject to approval, an Owner may place a flagpole on such Owner's Lot.

3. Except as expressly set forth herein, the Declaration shall continue in full force and effect according to its terms.






