

RELEASE OF EASEMENT

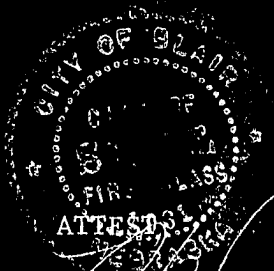
WHEREAS, on September 12, 1967, Howard D. Thompson and Ruth J. Thompson, husband and wife, granted to the City of Blair an easement for road purposes over real estate described as a circular tract of land located at the extreme south end of Thompson's Twin Elms Addition, as platted and recorded and more particularly described as follows: A full circle whose radius is 50.0 feet, the radius point being 50 feet north of the south line of Twin Elms Addition and on the center line of 16th Avenue, except that portion of 16th Avenue as dedicated on the plat of said Addition, in the City of Blair, Washington County, Nebraska, and

WHEREAS, said easement was recorded on September 13, 1967, in miscellaneous book S, at pages 215-216, of the records of Washington County, Nebraska, and

WHEREAS, the need for said easement has now terminated, and at a regular meeting of the City Council of the City of Blair, Nebraska held on March 26, 1968, a motion was passed authorizing and directing the Mayor and City Clerk of the City of Blair, Nebraska, acting on behalf of said City, to execute a release of said easement;

NOW THEREFORE, BY THESE PRESENTS, the City of Blair, Nebraska, hereby releases and abandons all right and interest granted to them by said easement.

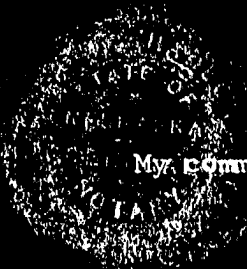
