RATIFICATION AND AMENDMENT TO BY-LAWS

This is an Amendment to the By-laws of the Twin Towers Condominium Association dated December 27, 1983 and recorded on December 30, 1983 in the office of Register of Deeds where the same is located in Deeds Book 1721 at Page 292 is made by the undersigned requisite owners of the Twin towers Condominium, located in Douglas County, Nebraska.

WHEREAS, Section 3 of the By-Laws of the Twin Towers Condominium Association, located in Deeds Book 1721 at Page 292 of the records of the Register of Deeds for Douglas County, Nebraska prohibits the use of proxy voting by unit owners on business of the Association; and,

WHEREAS, Section 7(g) of the Master Deed and Declaration establishing the Twin Towers Condominium, located in Deeds Book 1721 at Page 287 of the records of the Register of Deeds for Douglas County, Nebraska requires the approval of two-thirds (2/3 rds) or more of the total basic value of the Condominium to amend the Master Deed and Declaration and the By-Laws of the Condominium; and,

WHEREAS, the undersigned owners of more than two-thirds (2/3 rds) of the basic value of the Condominium desire to amend the By-Laws of the Association to delete the prohibition on proxy voting contained therein, and to permit the same.

NOW, THEREFORE, the By-Laws of the Twin Towers Condominium Association are deemed amended in the following manner:

1. The following sentence contained in Section 3 of the Bylaws of the Condominium Association, located in Deeds Book 1721 at Page 292 of the records of the office of the Register of Deeds of Douglas county, Nebraska is hereby deleted therefrom:

"No other form of proxy voting will be permitted."

2. The following sentence shall be substituted in its stead:

"Proxy voting shall be permitted on all lawful business of the Association that may come before any futue annual or special meeting of
