**AMENDMENT TO  
MASTER DEED**

The undersigned co-owners, representing two-thirds (2/3) or more of the total basic value of the condominium as required pursuant to Paragraph 7(g) of the Master Deed, hereby execute this Amendment to Master Deed (this “**Amendment**”) amending the Master Deed of the Twin Towers Condominium dated December 27, 1983 and recorded at Book 1721, Page 280 in the office of the Douglas County Register of Deeds (together with all prior amendments thereto, the “**Master Deed**”). All capitalized terms not defined herein shall have the meanings ascribed to such terms in the Master Deed. This Amendment is dated as of January 14, 2020, and shall be effective upon recording with the Register of Deeds of Douglas County, Nebraska.

**WITNESSETH:**

WHEREAS, the Board of Administrators of the Association and the undersigned co-owners desire to expressly authorize the Association to borrow funds and pledge security; and

WHEREAS, the Association and such co-owners desire to amend the Master Deed as set forth herein.

NOW, THEREFORE, the Master Deed is hereby amended as follows:

1. The following is hereby added to the Master Deed as new Paragraph 9:

“9. The Association may, with the approval of the Board of Administrators, incur liabilities and borrow money (the “**Indebtedness**”) in connection with the performance of the Association’s duties hereunder, and secure its obligation to repay such Indebtedness by mortgage or pledge of any of its property or income, or by an assignment of the Association’s right to future income, including the right to receive common expense assessments; provided, however, that the Association

may not, in whole or in part, mortgage or pledge the common elements or limited common elements. In addition, payments on such Indebtedness shall not exceed, in any fiscal year of the Association, an aggregate amount equal to thirty percent (30%) of the total assessments levied by the Association for such fiscal year. Assessments for the repayment of Indebtedness may be made in the same manner as other assessments for common element expenses, reserves and other expenses incurred by the Association pursuant to the Master Deed and Bylaws.”

IN WITNESS WHEREOF, the undersigned co-owners, representing two-thirds (2/3) or more of the total basic value of the condominium, have caused this Amendment to be executed as of the day and year first above written.
