ORDINANCE NO. 8751

AN ORDINANCE vacating the east-west alley in Block 61, University Place, an addition in the City of Lincoln, being the alley from 60th Street to 61st Street between St. Paul Avenue and Madison Avenue, reserving title to said alley so vacated in the City of Lincoln, and providing for the filing of a certified copy of this ordinance with the Register of Deeds of Lancaster County, Nebraska.

BE IT ORDAINED by the City Council of the City of Lincoln, Nebraska:

Section 1. That the east-west alley in Block 61, University Place, an addition in the City of Lincoln, being the alley from 60th Street to 61st Street between St. Paul Avenue and Madison Avenue, be and it hereby is vacated, subject to title to said alley so vacated remaining in the City of Lincoln.

Section 2. Immediately upon the taking effect of this ordinance the City Clerk shall file a certified copy of this ordinance in the office of the Register of Deeds of Lancaster County, Nebraska.

Section 3. This ordinance shall take effect and be in force from and after its passage and publication according to law.
