
The Second Amended and Revised Master Deed and Declaration of University Towers filed as Instrument No. 8612905 on May 8, 1986, is amended as follows:

There is added 76 square feet to Unit 208 from the common hallway being a space 5 feet 8 inches in width and 12 feet 10 inches in length as shown on the revised plan of Unit 208, attached hereto. The total square footage of all of the units in the condominium regime is now 193,664.

There is added to the common element the skywalk, the West 12 feet of Lot 3, Block 39, Lincoln, Lancaster County, Nebraska, and the interest in the East/West alley lying South of Lots 4, 5, and 6, Block 39, Lincoln Original, title of which is held by Commercial Federal Savings & Loan Association, as Nominee for University Towers Condominium Property Regime, Nebraska Higher Education Loan Program and Commercial Federal Savings & Loan Association.

REASON FOR AMENDING MASTER DEED

Entry to apartment 208 will be changed to conform with entries as in apartments 308, 408, and 508.

Space taken from common area hallway is 5 feet 8 inches wide by 12 feet 10 inches long and will become part of apartment 208, changing the square footage of Unit 208 from 1137 square feet, an additional 76 square feet making a total of 1213 square feet.

The Master Deed anticipated that the skywalk would be added as part of University Towers together with the West 12 feet of Lot 3, Block 39, Lincoln Original, for utility service to the condominium. Also, the East/West alley lying south of University Towers would become private property and owned by the adjacent property owners.

Added to the common area shall be the common interest with others in the skywalk; together with the West 12 feet of Lot 3, Block 29, Lincoln Original, for utility purposes for University Towers, and the common interest with others in the East/West alley lying South of Lots 4, 5, and 6, Block 39, Lincoln Original, title of which is held by Commercial Federal Savings & Loan Association as Nominee for University Towers, Commercial Federal Savings & Loan Association, and Nebraska Higher Education Loan Program, with University Towers Condominium Project Regime to accept a deed and an assignment of the Redevelopment Agreement with the City of Lincoln and the contract for the construction of the skywalk identified as filing instruments numbered 89-43890 and 89-14398 respectively.

The undersigned WILLIAM R.
