

UNIVERSITY TOWERS CONDOMINIUM PROPERTY REGIME SUBDIVISION AMENDMENT TO MASTER DEED AND DECLARATION

The University Towers Condominium Association (the "Association") hereby amends the Second Amended and Revised Master Deed and Declaration of the University Towers Condominium Property Regime ("Master Deed and Declaration") as hereinafter set forth.

RECITALS:

A. Haberlan Enterprises, Inc. ("Owner") is the owner of:

Theatre and Doghouse, University Towers Condominium Property Regime, according to the Master Deed and Declaration recorded September 30, 1997 as Inst. No. 77-26306, as amended by filings of record, records of Lincoln, Lancaster County, Nebraska ("Stuart Theatre Unit")

and has applied to the Association, pursuant to paragraph 7, c. of the Master Deed and Declaration to subdivide the Stuart Theatre Unit into two units.

Owner's application to subdivide the Stuart Theatre Unit was B. approved by the Association at a meeting of the Association's Board of Directors on April 20, 1999.

NOW, THEREFORE, the Second Amended and Revised Master Deed and Declaration of the University Towers Condominium Property Regime is amended to divide the Stuart Theatre Unit into two units, one to be designated "Unit 140" and the other to be designated "Unit 124" as set forth in the plat and plan attached hereto as Exhibit A and coded "G" and "G-1," respectively, thereon. The portion of the common

interest assessment allocated to the Stuart Theatre Unit shall hereafter be allocated 74.60% to Unit 140 and 25.40% to Unit 124. The eight (8) votes in Association matters allocated to the Stuart Theatre Unit shall hereafter be allocated six (6) votes to Unit 140 and two (2) votes to Unit 124.

The Board of Directors of the Association has consented to and approved the subdivision and has caused the amended floor plans for the basement, street level, loge level-theater, second floor, third floor and fourth floor to be amended to reflect the subdivision of the Stuart Theatre Unit as set forth in the attached Exhibit A. The amended description and unit designation set forth on Exhibit A shall amend only the description and designation of the Stuart Theatre Unit and no description, designation, notation or reference to other units or common areas set forth thereon shall amend the description or designation of other units or common areas set forth in the Master Deed and Declaration.

Haberlan Enterprises, Inc., joins in this Amendment as Owner of the Stuart Theatre Unit.




Upper Theater Plan/Balcony Fourth Floor Plan


