## ASSIGNMENT OF DECLARANT STATUS

WHEREAS, Assignor is the Successor Declarant under the Declaration of Covenants, Conditions and Restrictions for Lots 1 through 63, Inclusive, and Outlot 1, Villas of Saddlebrook, dated February 7, 2002 and filed with the Douglas County Register of Deeds on February 13, 2002, as \*Instrument No. 200203476; as amended by First Amendment to Declaration of Covenants, Conditions and Restrictions for the Villas of Saddlebrook, a subdivision in Douglas County, Nebraska dated May 18, 2005, and filed with the Douglas County Register of Deeds on October 31, 2005, as Instrument No. 2005136958, and as further amended by the Second Amendment to Declaration of Covenants, Conditions and Restrictions for the Villas of Saddlebrook, a subdivision in Douglas County, Nebraska dated June 19, 2007, and filed with the Douglas County Register of Deeds on June 20, 2007, as Instrument No. 2007069868, and as further amended by the Third Amendment to Declaration of Covenants, Conditions, and Restrictions for the Villas of Saddlebrook, a subdivision in Douglas County, Nebraska dated December 21, 2011, and filed with the Douglas County Register of Deeds on December 28, 2011 as Instrument No. 2011112492, (as amended, the "Declaration"), as may be further amended;

WHEREAS, the real estate subject to the Declaration is legally described as follows:

- 1. The Assignor hereby assigns to Assignee all of the rights and duties of the Assignor as Declarant under the Declaration.
- 2. The Assignee accepts the foregoing assignment and assumes all rights and duties of Assignor as successor-in-interest to the Assignor as Declarant under the Declaration.
- 3. Assignee represents and acknowledges to Assignor that Assignee has examined the Declaration and as a result of such examination and not in reliance upon any representations or statements of Assignor accepts the assignment from Assignor as stated herein.
