

ORDINANCE NO. 935

AN ORDINANCE EXTENDING THE CITY LIMITS OF THE CITY OF BLAIR, NEBRASKA, TO INCLUDE URBAN AND SUBURBAN CONTIGUOUS LAND DESCRIBED AS BEGINNING AT THE WEST $\frac{1}{4}$ CORNER OF SECTION 11, TOWNSHIP 18 NORTH, RANGE 11, EAST OF THE SIXTH PRINCIPAL MERIDIAN IN WASHINGTON COUNTY, NEBRASKA, RUNNING THENCE SOUTH ALONG THE SECTION LINE TO A POINT ON THE SOUTHEASTERLY RIGHT OF WAY OF THE CHICAGO & NORTH WESTERN RAILWAY COMPANY; RUNNING THENCE SOUTHWESTERLY ALONG SAID RIGHT OF WAY TO THE SOUTH LINE OF SECTION 10, TOWNSHIP 18 NORTH, RANGE 11, EAST; RUNNING THENCE EAST ALONG THE SECTION LINE TO THE $\frac{1}{4}$ CORNER OF THE SOUTH LINE OF THE SOUTHWEST QUARTER OF THE SOUTHWEST QUARTER (SW $\frac{1}{4}$ SW $\frac{1}{4}$) OF SECTION 11, TOWNSHIP 18 NORTH, RANGE 11, EAST; RUNNING THENCE NORTH ALONG THE $\frac{1}{4}$ LINE TO THE SOUTHEASTERLY RIGHT OF WAY OF STATE HIGHWAY 91; RUNNING THENCE NORTHEASTERLY ALONG SAID RIGHT OF WAY TO THE EAST-WEST $\frac{1}{4}$ LINE OF SECTION 11, TOWNSHIP 18 NORTH, RANGE 11 EAST; RUNNING THENCE WEST ALONG SAID $\frac{1}{4}$ LINE TO THE POINT OF BEGINNING: BEGINNING AT THE $\frac{1}{4}$ CORNER EAST OF THE NORTHWEST CORNER OF SECTION 14, TOWNSHIP 18 NORTH, RANGE 11 EAST OF THE SIXTH PRINCIPAL MERIDIAN IN WASHINGTON COUNTY, NEBRASKA; RUNNING THENCE WEST ALONG THE SECTION LINE TO THE $\frac{1}{4}$ CORNER ON THE NORTH LINE OF THE NORTHWEST QUARTER OF THE NORTHWEST QUARTER (NW $\frac{1}{4}$ NW $\frac{1}{4}$) OF SECTION 14, TOWNSHIP 18 NORTH, RANGE 11 EAST; RUNNING THENCE SOUTH ALONG THE $\frac{1}{4}$ LINE A DISTANCE OF 1450.0 FEET; RUNNING THENCE SOUTHEASTERLY TO A POINT ON THE EAST-WEST CENTERLINE OF SECTION 14-18-11, SAID POINT BEING 355.0 FEET WEST OF THE $\frac{1}{4}$ CORNER EAST OF THE WEST $\frac{1}{4}$ CORNER OF SECTION 14-18-11; RUNNING THENCE SOUTH ALONG THE $\frac{1}{4}$ LINE TO THE CENTER OF THE SOUTHWEST QUARTER (SW $\frac{1}{4}$) OF SECTION 14-18-11; RUNNING THENCE EAST ALONG THE $\frac{1}{4}$ LINE TO THE $\frac{1}{4}$ CORNER NORTH OF THE SOUTH $\frac{1}{4}$ CORNER OF SECTION 14-18-11; RUNNING THENCE SOUTH ALONG THE NORTH-SOUTH $\frac{1}{4}$ LINES OF SECTIONS 14 AND 23, TOWNSHIP 18 NORTH, RANGE 11 EAST TO A POINT 300.0 FEET NORTHWESTERLY FROM AND MEASURED RADially FROM THE NORTHWESTERLY RIGHT OF WAY OF U.S. HIGHWAY #30; RUNNING THENCE SOUTHWESTERLY ALONG A LINE 300.0 FEET FROM AND PARALLEL TO SAID RIGHT OF WAY TO A POINT ON THE EAST-WEST $\frac{1}{4}$ LINE OF SECTION 23, TOWNSHIP 18 NORTH, RANGE 11 EAST; RUNNING THENCE EAST ALONG THE $\frac{1}{4}$ LINE TO THE EASTERLY RIGHT OF WAY OF STATE HIGHWAY #133; RUNNING THENCE NORTHERLY ALONG SAID RIGHT OF WAY TO A POINT ON THE SOUTHEASTERLY RIGHT OF WAY OF U. S. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF BLAIR, NEBRASKA:

SECTION 1. Right of Way of South Street in the City of Blair, Nebraska; running thence West along said South Right of Way to the Westerly Right of Way of U.S. Highway #73; running thence South and Southeasterly along said Right of Way to a point on the North-South $\frac{1}{4}$ line of Section 13, Township 18 North, Range 11 East; running thence North along the $\frac{1}{4}$ line to the point of beginning; beginning at the Northeast corner of Tax Lot 17 in Section 1, Township 18 North, Range 11, East of the Sixth Principal Meridian in Washington County, Nebraska; running thence North along the projected East line of said Tax Lot 17 a distance of 193.0 feet; running thence West along a line 300.0 feet North of and parallel to the North Right of Way of Adams Street in the City of Blair, Nebraska, to a point on the East line of Tax Lot 27 in Section 1, Township 18 North, Range 11 East; running thence North along the East line of Tax Lot 27 a distance of 500.0 feet; running thence West parallel to the North line of Adams Street to the West line of Tax Lot 27; running thence South along the West line of Tax Lot 27 to a point 161.0 feet North of the North Right of Way of Adams Street; running thence East on a line 161.0 feet North of and parallel to the North line of Adams Street to the Northeast corner of Tax Lot 37 in Section 1, Township 18 North, Range 11 East; running thence South to the Northwest corner of Tax Lot 19 in Section 1, Township 18 North, Range 11 East; running thence East along the North lines of Tax Lots 19, 18, 21, 30, 20 and 17 in Section 1, Township 18 North, Range 11 East, to the point of beginning, all in Washington County, Nebraska.

SECTION 2. This ordinance shall take effect from and after its passage, approval and publication as provided by law.

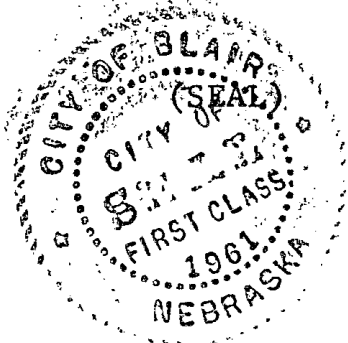

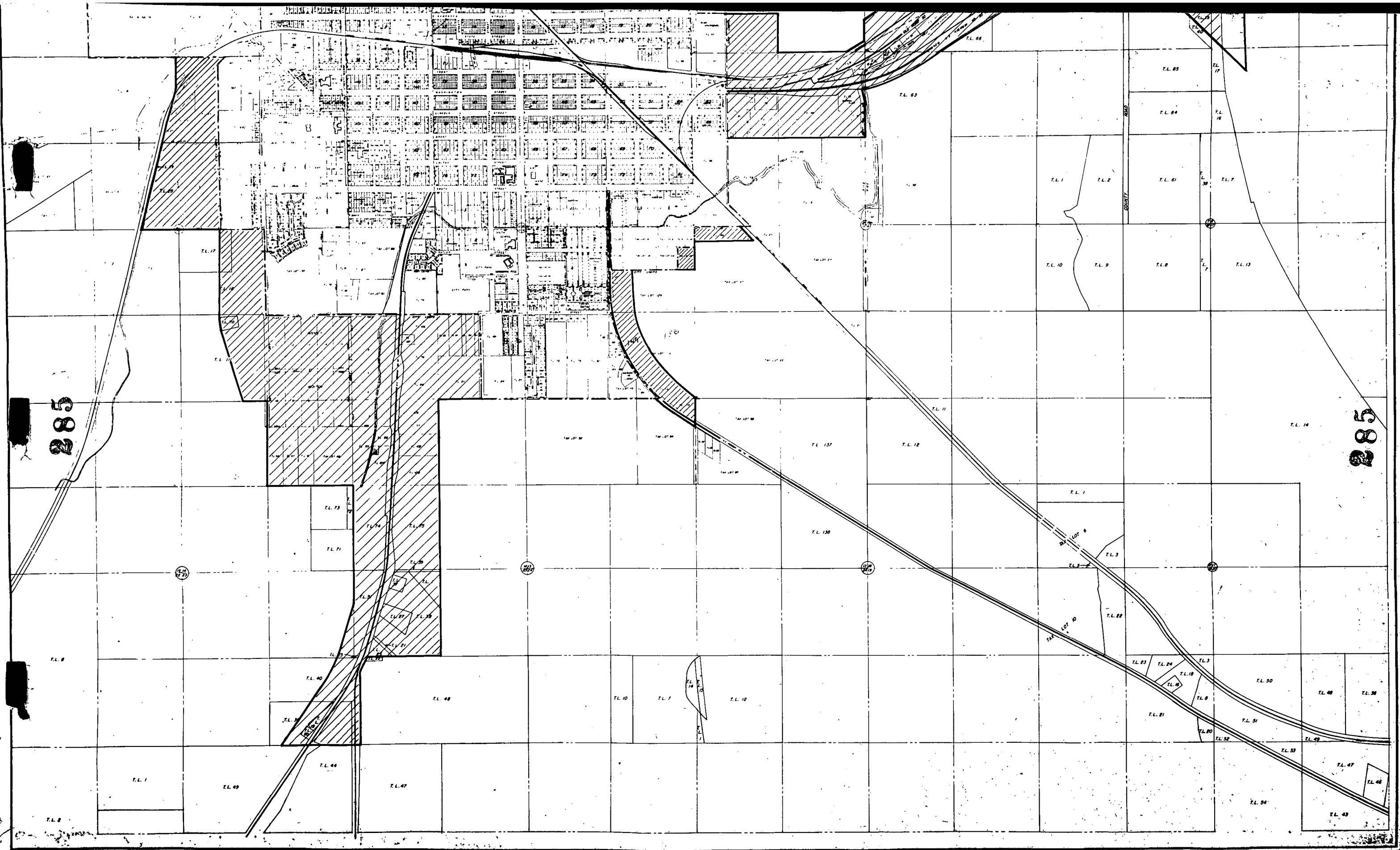
