AMENDMENT TO PROTECTIVE COVENANTS

THIS AMENDMENT TO PROTECTIVE COVENANTS is made the date hereinafter set forth by Celebrity Homes, Inc., a Nebraska corporation.

RECITALS

were recorded by Celebrity Homes, Inc., a Nebraska corporation, Declarant and Developer, in the office of the Register of Deeds of Douglas County, Nebraska at Book 1253 Page 320 of the Miscellaneous Records.

B. Paragraph 21. of the Declaration provides that for a period of ten (10) years following June 29, 1998, the Protective Covenants may be amended, modified or supplemented by the Developer by executing and recording one or more duly acknowledged Amendments to Protective Covenants in the Office of the Register of Deeds of Douglas County, Nebraska.

NOW, THEREFORE, Developer hereby declares that the Protective Covenants recorded on June 29, 1998 at Book 1253 Page 320 in the Miscellaneous Records of the office of the Register of Deeds of Douglas County, Nebraska, and any amendments thereto, should be and hereby are amended in the following manner:

I. by deleting therefrom the preliminary paragraph and adding in its place and stead the following:

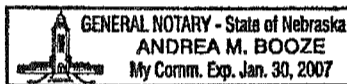
